

Ordinance No 231

Ord. No. 231  
 An Ordinance to appropriate the sum of seven hundred and fifty dollars out of the general fund of the city to pay the purchase price of a perpetual right of way for the City of Albany over certain lands purchased by the city of the Heirs of Walter Montith, for the purpose of erecting and maintaining a high steel for Wagon bridge from the northern terminus of Calapooia Street in said city across the Willamette River

Whereas the city of Albany has purchased of D.B. Montith, Charles Montith, Mary Ann Montith and Malcolm Montith for the sum of \$750.00 the following described tract of land to wit, Beginning in the center of Calapooia Street on the north line of first Street in said city and running thence northwesterly 274.7 feet on a line parallel with Calapooia Street; thence northwesterly and easterly on a circular curve, the radius of which is 192.5 feet; thence northwesterly and easterly and on a tangent with said curve to the south bank of the Willamette River at low water. said strip of land or right of way to extend 20 feet on each side from the center line of said bridge and its southern approach wherever the same or any part thereof passes over said strip of land; said tract of land to be used as a perpetual right of way, by said city, for the purpose of erecting and maintaining thereover a high steel Wagon bridge to extend across the Willamette River; therefore

The People of the City of Albany do  
ordain as follows:

Section 1. That there be and hereby is, appropriated out of the funds, of the City applicable thereto for the purpose of paying for the abovescribed strip of land the sum of \$750<sup>00</sup> the said sum to be paid by the Treasurer of the City to said D B Mintz, Charles Mintz, Margant Mintz and Malcolm J Mintz upon the presentation by them of a warrant therefor signed by the City Recorder, and said Recorder is hereby ~~ordain~~ <sup>ordered</sup> and directed to issue to said persons such warrant as soon as a quick claim deed for said strip of land is delivered or ready to be delivered by said parties to the said city of Albany Oregon

Section 2. This ordinance shall be in full force and effect from and after its approval by the Mayor.


