

Ordinance No. 540

All Ordinances authorizing the Mayor and Recorder of the City of Albany Oregon to enter into and sign a contract in writing for the construction of lateral sewers across Perry Street between Sixth Street and the Southern boundary line of said City of Albany, to connect the following described blocks in the City of Albany Oregon with the main sewer in said Perry Street; to wit; blocks 47-48-49-53-54-67-68-75, (College square), 76-91-92, (College square) 99 and 100; and also authorizing said Mayor and Recorder to enter into and sign a contract for the construction of a lateral sewer through the center of block 102 from the east line of Montgomery Street to the west line of Railroad Street, in Hackleman's addition to the City of Albany Oregon.

Ord. 240

The People of the City of Albany do Ordain as follows:

Section 1: That the Mayor and Recorder of the City of Albany Oregon are hereby authorized, directed, and empowered to enter into and sign on behalf of the City of Albany Oregon written article of agreement, for constructing, and laying lateral sewers across Perry Street between Sixth Street and the Southern boundary line of said City of Albany, to connect block 47-48-53-54-67-68-75 (College square) 76-91-92 (College square) 99 and 100, all of said blocks abutting said Perry Street, with the main sewer in said Perry Street; and also for constructing and laying a lateral sewer through the center of block 102, in Hackleman's addition to the City of Albany Oregon, from the west line of Railroad Street to the east line of Montgomery Street; Provided that such contracts shall not be entered into and the articles of agreement signed by the Mayor and Recorder of the City of Albany, on behalf of said City until after bids for constructing said lateral sewers have been advertised for and received by the Council

of said City, as provided by Ordinance for the letting contracts for city work, and the contracts for ~~sewerwork~~ let by said Council to the lowest responsible bidder, and the contract price for constructing said sewers fixed and agreed upon.

Section 2: This Ordinance shall take effect and be in full force from and after its approval by the Mayor.
