Ord. No. 330 An Ordinance, to amend Section 1. of Ordinance No. 285 Entitled, "An Ordinance to prohibit the riding of Bicycles, Tricycles, or Velocipedes on the sidewalks, on certain streets in the City of Albany, and to regulate the riding of the same on the sidewalks, and over the Steele Wagon Bridge across the Willamette river in said City; Passed April 9<sup>th</sup> 1895, and Approved April 11<sup>th</sup> 1895.

The People of the City of Albany, do Ordain as follows:

Section 1: That Section 1. of Ordinance Number - 285, Entitled, "An Ordinance to prohibit the riding of Bicycles, Tricycles, or Velocipedes, on the sidewalks, on certain streets in the city of Albany, and to regulate the riding of the same on the sidewalks, and over the Steele Wagon Bridge across the Willamette river in said City, Passed April 9<sup>th</sup> 1895, and Approved April 11<sup>th</sup> 1895. be, and the same is hereby amended so as to read as follows:

Section 1: That it shall be unlawful for any person, or persons, to ride a Bicycle, Tricycle, or Velocipede on the sidewalk on First, or Second Street, between Washington, and Baker Streets, or on Broadalbin, Ellsworth, or Lyon Streets, between First, and Second Street, or on the west side of Avery street, between First, and Second Street, or on the East side of Lyon street, from Second Street, to Ninth street, provided, that Drifters using any of such vehicles for purpose of travel shall be exempt from the provisions of this section.

Section 2: That Section 1. of Ordinance 285, be, and the same is hereby repealed.

Section 3: This Ordinance shall take effect and be in full force power, and after its approval by the Mayor.
