

ORDINANCE NO. 347

Ord. No. 347 An ordinance to amend section two(2) of an ordinance
Rep 1506 entitled, "An ordinance to regulate travel upon the
steel bridge belonging to the city of Albany, which
spans the Willamette River within the corporate
limits of said City of Albany; to establish toll gates
or gates thereon; and to provide for the collection of
toll from all persons and property passing over
said bridge or through the gates thereon.

The People of the City of Albany do ordain as follows:

Section I. That section two(2) of an ordinance enti-
tled, "An ordinance to regulate travel upon the
Steel Bridge belonging to the City of Albany and
which spans the Willamette River within the
corporate limits of the said city of Albany; to
establish toll gate or gates thereon and to pro-
vide for the collection of toll from all persons
and property passing over said bridge or through
the gates thereon;" be amended so as to read
as follows;

Section II That there shall be charged and collected
from all persons and property passing through
the gate or gates, so built and maintained
upon said steel bridge, toll as and for com-
pensation for travelling over and across
said bridge as follows:

For each vehicle drawn by four horses,

mules or oxen, round trip or one way, 25¢.

For each vehicle drawn by two horses, mules
or oxen, round trip or one way, 15¢.

For each vehicle drawn by one horse or mule or
ox, round trip or one way, 10¢.

For each bicycle or tricycle, round trip or
one way, 5¢.

For each tandem, when used by one person,^{10¢}
if used by two persons, 10¢ round trip
or one way.

For each person on horseback, round trip
or one way, 10¢.

For each footman, round trip or one way.^{10¢}

For each threshing machine, one way, \$1.50.

For each engine when drawn by other power
than steam, one way, \$1.50.


For each wood-saw, round trip or one way, 50¢.
 For each traction engine, one way, \$2.00.
 For each sheep, one way, 2½¢.
 For each goat one way, 2½¢.
 For each hog one way, 2½¢.
 For each horse or mule, whether being driven,
 loose or led, one way, 5¢.
 For each head of cattle, whether being driven,
 loose or led, 5¢ one way.

Provided, however, that the City Council may by resolution provide for the sale of non-transferable season or monthly tickets, for any or all of the classes of persons or property above mentioned, and may, by resolution fix the price therefor.
