

ORDINANCE NO. 456

Sidewalk adjacent to Lot 5, Block 15, Hook 4th add.

An Ordinance authorizing the construction of a wooden sidewalk six feet in width on the north side of Second Street and adjacent to the south line of Lot No. 5, in Block No. 15 in Hook 4th addition to the City of Albany, Oregon, at the cost of the owner of said real property, and authorizing the Mayor and Recorder of said City to enter into a contract for the construction of the same.

The People of the City of Albany do ordain as follows:

Section One: That there shall be constructed a wooden sidewalk six feet in width on the north side of Second Street and adjacent to the south line of Lot No. 5, in Block No. 15, in Hook 4th addition to the City of Albany, Oregon, at the cost and expense of the owner or owners of said property and that the Mayor and Recorder of said City of Albany be and they are hereby authorized, directed and empowered to enter into, and sign on behalf of the said City of Albany, written articles of agreement for the construction of said sidewalk provided that said contract shall not be entered into, or said articles signed by the Mayor and Recorder until after the proposal for the construction of said wooden sidewalk has been advertised for in the manner provided for by the City Charter, and the Ordinance's regulating the manner of awarding contracts, and bids have been received and considered by the Council, and the contract awarded by the Council, and the costs and expenses of constructing the same have been ascertained, fixed and determined.

Section Two: That the costs and expenses of the construction of said sidewalk, shall be made a lien upon the said real property adjacent to which the same is constructed, to be created and enforced in the manner provided by the Charter and the Ordinance of said City.

Section Three: In as much as there is urgent necessity for the immediate construction of said sidewalk on said street, an emergency is declared to exist and this Ordinance shall be in full force and effect from and after its approval by the Mayor.
