

Ordinance No. 472

An ordinance to prohibit the selling, bartering, giving away or otherwise disposing of near beer, spirituous, vinous or mail liquors that are not intoxicating, and to declare an emergency.

The people of the City of Albany do ordain as follows:

Section 1. That no person or persons shall be permitted to sell, barter, give away or otherwise dispose of any near beer, spirituous, vinous or malt liquors that are not intoxicating within the corporate limits of the City of Albany, Linn County, Oregon.

Section 2. That every person who shall sell, barter, give away or otherwise dispose of any near beer, spirituous, vinous or malt liquors, that are not intoxicating, within the corporate limits of the City of Albany, Lina County, Oregon, shall upon conviction thereof before the Recorder's Court of said city be punished by a fine of not less than fifty dollars, nor more than one hundred dollars, or by imprisonment in the city jail not less than twenty-five days, nor more than fifty days, or by both such fine and imprisonment at the discretion of the court; and each and every selling, bartering, giving away or otherwise disposing of any near beer, spirituous, vinous or malt liquors that are not intoxicating, within the corporate limits of said city, shall constitute a separate and distinct violation of the provisions of this section, and the provisions of this ordinance, and the persons guilty thereof, shall, upon conviction thereof before the Recorder's Court, be punished as in this section provided. Provided, however, that the provisions of this ordinance shall not apply to druggists who sell such liquor for medical purposes only.

Section 3. That inasmuch as there are large quantities of near beer, spirituous, vinous and malt liquors that are not intoxicating being sold, bartered, given away and otherwise disposed of within the City of Albany, by which the peace and good order of the city is disturbed, an emergency is hereby declared and found to exist, and this ordinance shall be in full force and effect from and after its approval by the mayor of said city.
