Ordinance declaring a surplus on account of Street paving by the Warren Construction Company per Contract # on First Street from the East 1st from Lyon Street to the West Curbline of Montgomery Street, in the City of Albany Oregon, and directing the Recorder of said City to place to the credit of the several owners of the various parcels of real-estate abutting upon said portion of said First Street, heretofore assessed for making such improvement, and entered upon the Docket of City Liens of said City of Albany, their proper share of such surplus.

The People of the City of Albany do ordain as follows:-

Section 1. That a surplus of 7% percent is hereby ascertained and declared to exist upon the completion of the contract entered into by and between the City of Albany, and the Warren Construction Company for the improvement of First Street from the Eastline of Lyon Street to the West Curbline of Montgomery Street, in favor of each of the several owners of the various parcels of real-estate abutting upon said portion of said First Street heretofore assessed for making such improvement as their several interests may appear.

Section 2. The Recorder of the City of Albany, is hereby directed to enter in the Docket of City Liens, in the surplus column thereof, a credit of 7% percent, based upon the several amounts heretofore assessed and entered therein to defray the cost of the improvement of said portion of said First Street, said surplus being in favor of the following named persons, Owners of such various parcels of real estate, in the several amounts as follows - to-wit:-

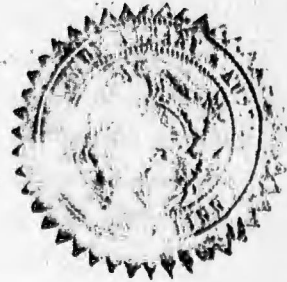
