

## Working franchise of Portland, Eugene &amp; Eastern Railway Co.

Ord 559 An Ordinance to revoke all right, privilege or franchise  
 granted to lay down, build, construct or maintain line or lines of  
 franchise railway or a system of single track railway with  
 of Portland convenient switches, turn-outs, curves, connections or  
 Eugene - turn-tables for the purpose of operating a railway  
 Easton Ry. Co. or conveying power or electrical current for its use or  
 to put up, erect, maintain or use poles or overhead wires  
 or lay down construct maintain or use underground,  
 slots, conduits, under-ground wires, conductors or cables  
 in, over or upon the following streets and portion of  
 streets within the City of Albany, Oregon; to wit:

Beginning at a point on the Willamette River at  
 the north end of Calapooia Street in the City of Albany,  
 Oregon, thence running south on Calapooia Street to  
 First Street; also beginning at a point 224 feet south of the  
 intersection of Calapooia Street by First Street and  
 running thence south on Calapooia Street to Ninth Street.  
 Also beginning at the intersection of Lyon Street and First  
 Street in said City and running thence East or, First  
 Street to the Eastern limits of said City; also beginning at  
 Lyon Street and Second Street and running East to the City  
 limits on Second Street; also beginning at a point where  
 Eighth Street in said City of Albany intersects Main Street  
 in said City and running thence west on Eighth Street to  
 Montgomery Street, thence across block six in Hackmann's  
 Second Addition to said City of Albany to Ninth Street where  
 it intersects Baker Street, thence west on Ninth Street to the  
 Western limits of said City; also beginning at the intersection  
 of Calapooia Street with Seventh Street in said City of Albany  
 and running thence West on Seventh Street to the Western  
 limits of said City; also beginning at a point on the Willamette  
 River at the north end of Lyon Street in said City of Albany  
 and running thence South on Lyon to First Street; also  
 beginning at the intersection of First and Main Streets in said  
 City, and running thence south on Main Street to its intersection  
 with Eighth Street.

Whereas on May 2<sup>nd</sup>, 1909 an ordinance was passed  
 by the common council of the City of Albany, Oregon, granting  
 unto the Portland, Eugene and Eastern Railway Company  
 its assigns and successors the right, privilege and franchise  
 to lay down, build, construct and maintain lines of  
 railway, and a system of single track railway, with  
 convenient switches, turn-outs, curves, connecting and

turn-tables, and for the purpose of operating said railway and conveying power and electrical currents for its use, to put up, erect, maintain and use poles and over-head wires, and lay down, construct, maintain, and use under-currents slate, conduct, under-ground wires, conductors and cables, in, over, and upon the following streets and portion of streets within the City of Albany, Oregon, to-wit: Beginning at a point on the Willamette River at the North end of Calapooia Street, in the City of Albany, Oregon, thence running south on Calapooia Street to First Street; Also, beginning at the intersection of Calapooia Street and First Street, in said City, and running thence East on First Street to the eastern limits of said City; also, beginning at Lyon Street on Second and running East to the City limits on Second Street; Also beginning at a point where Eighth Street in said City of Albany, intersects Main Street, in said City, and running thence west on Eighth Street to Montgomery Street, thence across block six in Blackman's Second Addition to said City of Albany to Ninth Street where it intersects Baker Street, thence West on Ninth Street to the western limits of said City; Also, beginning at the intersection of Calapooia Street with Seventh street, in said City of Albany, and running thence West on Seventh Street to the western limits of said City. Also, beginning at a point on the Willamette River at the North end of Lyon Street, in said City of Albany and running thence South on Lyon Street to the Southern Pacific Railway Depot in said City of Albany, Oregon. Also, beginning at the intersection of First and Main Streets, in said City, and running thence South on Main Street to its intersection with Eighth Street, which ordinance was approved by the Mayor May 25<sup>th</sup> 1909.

And whereas said Portland, Eugene, and Eastern Railway Company accepted said franchise June 18<sup>th</sup>, 1909.

And whereas said ordinance and franchise provides "In the event that the said Portland, Eugene, & Eastern Railway Company, its assigns or successors, shall fail to construct and operate said Street Railway upon any street or portion of street, the use of which is by this ordinance granted to the said Portland, Eugene, and Eastern Railway Company, its assigns and successors, for Street Railway purposes, within two years from

the date of the acceptance of this franchise, then this franchise, as to such street or portion of street not so used, and occupied hereunder, shall be forfeited to the City of Albany!

And whereas said Portland, Eugene & Eastern Railway Company, its assigns or successors has failed to construct or operate a street railway over or upon the following streets or portion of streets.

Beginning at a point on the Willamette River at the North end of California Street, in the City of Albany, Oregon thence running South on California Street to First Street; also beginning at a point 224 feet South of the intersection of California Street by First Street and running thence South on California Street to Ninth Street; also beginning at the intersection of Lyon Street and First Street in said City and running thence East on First Street to the Eastern limits of said City; also beginning at Lyon Street on Second Street and running East to the City limits on Second Street; also beginning at a point where Eighth Street in said City of Albany intersects Main Street in said City and running thence West on Eighth Street to Montgomery Street, thence across block and in Hackmann's Second Addition to said City of Albany to Ninth Street where it intersects Baker Street, thence West on Ninth Street to the western limits of said City; also beginning at the intersection of California Street with Seventh Street in said City of Albany and running thence West on Seventh Street to the western limits of said City; also beginning at a point on the Willamette River at the North end of Lyon Street in said City of Albany and running thence South on Lyon to First Street; also beginning at the intersection of First and Main Streets in said City, and running thence South on Main Street to its intersection with Eighth Street, but has forfeited to the City of Albany all right and privilege under said ordinance and franchise, as to said streets:

The People of the City of Albany do ordain as follows:

Section 1. That all right, privilege or franchise to lay down, build, construct or maintain line or lines of railway, or a system of single track railway with convenient switches, turn-backs, curves, connections or turn-tables, for the purpose of operating a railway or conveying power or electrical current for its use or to put up, erect, maintain or use

poles or overhead wires or lay down, construct, maintain or use under currents, slots, conduits, under-ground wires, conductors or cables in, over or upon the following streets and portion of streets within the City of Albany, Oregon, to-wit, Beginning at a point on the Willamette River at the North end of Calapooia Street in the City of Albany, Oregon, thence running South on Calapooia Street to First Street; also beginning at a point 224 feet South of the intersection of Calapooia Street by First Street and running thence South on Calapooia Street to Ninth Street; also beginning at the intersection of Lyon Street and First Street in said City and running thence East on First Street to the Eastern limits of said City; also beginning at Lyon Street on Second Street and running East to the City limits on Second Street; also beginning at a point where Eighth Street in said City of Albany intersects Main Street in said City and running thence West on Eighth Street to Montgomery Street, thence across block six in Blackman's Second Addition to said City of Albany to Ninth Street where it intersects Baker Street, thence West on Ninth Street to the Western limits of said City; also beginning at the intersection of Calapooia Street with Seventh Street in said City of Albany and running thence West on Seventh Street to the Western limits of said City; also beginning at a point on the Willamette River at the North end of Lyon Street in said City of Albany and running thence South on Lyon to First Street; also beginning at the intersection of First and Main Streets in said City, and running thence South on Main Street to its intersection with Eighth Street, of the said Portland, Eugene and Eastern Railway Company, its assigns and successors to and the same is hereby revoked, cancelled annulled and for naught held.

Section 2. This ordinance shall take effect and be in force from and after 30 days after its approval by the Mayor!
