

Ord. No. 619  
Amend. 707. Ordinance No. 468 of the City of Albany, entitled "an ordinance relating to the construction of sidewalks and curbing within certain limits in the City of Albany and repealing all ordinances and parts of ordinances in conflict therewith" passed by the council November 10, 1908, approved by the Mayor November 11th, 1908.

The People of The City of Albany Do Ordain as Follows:

Section 1. That Section 2 of said Ordinance No. 468 be and the same is hereto amended so as to read as follows: Section 2. The provisions of this ordinance shall apply to the districts bounded and described as follows:-

Beginning at the Southwest corner of Block No. 2 in Shackleman's third addition to the City of Albany, Oregon, running thence Westerly on the North line of Water Street, to the South East corner of Block No. 16 in Shackleman's Addition to said City of Albany; thence Southerly on the West line of La Fayette Street, to the South East corner of Block No. 17 in said addition; thence Westerly on the North line of First Street to the East line of Lyon Street; thence Northerly on the East line of Lyon Street to the North line of Water Street; thence Westerly on the North line of Water Street to the West line of Washington Street; thence South on the West line of Washington Street to the North line of First Street; thence Westerly on the North line of First Street, to the West line of Calapooia Street; thence Southerly on the West line of Calapooia Street to the North line of Third Street; thence Westerly on the North line of Third Street to the West line of Vine Street; thence Southerly on the West line of Vine Street to the North line of Fourth Street; thence Westerly on the North line of Fourth Street to the West line of Walnut Street; thence Southerly on the West line of Walnut Street to the North line of Fifth Street; thence Westerly on the North line of Fifth Street to the West line of Elm Street; thence Southerly on the West line of Elm Street to the North line of Second Street; thence Westerly on the North line of Second Street to the South East corner of Block No. 11; thence Southerly to the Southwest corner of Block No. 6; thence Easterly on the North line of Block No. 6 to East line of Elm Street; thence South on the East line of Elm Street to the South East corner of Block No. 10; thence South on the Southern Addition to the City of Albany; thence Easterly on the North side of Twelfth Street to the East line of Willow Street; thence Southerly on the East line of Willow Street to the North line of Tenth Street; thence Westerly on the North line of Tenth Street to the East line of Nine Street; thence Southerly on the North

of Luns Street to the South line of Ninth Street; thence Easterly on the South line of Ninth Street to the East line of Main Street; thence Northward on the East line of Main Street to the place of beginning all in the City of Albany, Linn County, Oregon.

Section 2. That Section 4 of said Ordinance No. 408 be and the same is hereby amended so as to read as follows: Section 4. That all sidewalks that may hereafter be constructed on Washington, Ferry, Broadalbin, Ellsworth, Lyon and Baker Streets, from First to Second Street, within the district described in Section 2 of this ordinance shall be twelve feet wide;

That all sidewalks that may hereafter be constructed on Washington, Ferry, Broadalbin, Ellsworth and Lyon Streets, running from First Street North to the South line of Water Street, within the district described in Section 2 of this ordinance, shall be ten feet wide.

Section 3. Whereas conditions are such that this ordinance is necessary for the immediate preservation of the public health and safety, and emergency exists and an emergency is hereby declared to exist and this ordinance shall take effect and be in full force from and after its approval by the Mayor.
