

Ord 692

An ordinance to ascertain, determine and declare the cost of constructing a cement sidewalk on Tenth Street on the South side of and adjacent to the West half of the Southwest quarter of Block No. 74 in the Northern Addition to the City of Albany, Oregon, also on Caiapocia Street on the West side of and adjacent to said West half of the Southwest quarter of said Block No. 74 in the Northern Addition to the City of Albany, and to assess thereon and to lay a lien upon said land and directing said lien to be entered in the books of City Clerks.

Whereas the said day of July 28, 1913, Superintendent of Streets of the City of Albany reported by writing to the Council that a sidewalk should be constructed on the East side of and adjacent to the West half of the Southwest quarter of Block No. 74 in the Northern Addition to the City of Albany, Oregon, also on Caiapocia Street on the West side of and adjacent to said West half of the Southwest quarter of said Block No. 74 in the Northern Addition to the City of Albany, as required;

And whereas the Council on said day of July 28 duly passed Resolution No. 28 ordering said sidewalks constructed within twenty days from said July 28, 1913, which resolution specified the width and location thereof, the material to be used and that the construction should be in accordance with Ordinance No. 466; and

Whereas within five days after the said order to build so made on July 28, 1913, the Superintendent of Streets did post two notices upon said West half of the Southwest quarter of Block No. 74 in the Northern Addition to the City of Albany, Oregon, adjacent to each of said sidewalks ordered to be built, headed "Notice to Build Sidewalk", in letters not less than one-half inch in length and which said notice in legible characters, directed to the owners of said property, at the time, to build said sidewalks within twenty days from said July 28, 1913; and

Whereas the Superintendent of Streets did file with the Recorder an affidavit of the posting of said notices, stating the date when and the place where the same was posted; and

Whereas the Recorder did within five days from said July 28, 1913, and forward a notice to build said sidewalk to the owners of said property, at the time, directed to the post office address of such owners, to wit, Albany Oregon; and

Whereas the owner of said West half of the Southwest quarter of Block No. 74 in the Northern Addition to the

City of Albany, Oregon, to wit, D. H. Stone, Chairman, reported and considered a bill to build sidewalk within the time ordered by the council's and

When as the superintendent of streets has built said sidewalk and kept an accurate record of the cost of labor and material in building said sidewalk and reports to said council also certified and has reported a sworn receipt for the cost of said sidewalk together with a description of the work done and expended and for the cost of sidewalk along said street and sidewalk has been built, and

Whereas the council has inspected the said report of said superintendent of streets of the construction of said sidewalk and the cost thereof, which cost is the sum of \$125.76, and

It seems the council deem the same to be reasonable, which said cost is hereby approved.

Therefore

The People of the City of Albany Do Ordain as follows:

Section 1. That the cost of building the sidewalk on Tenth Street on the East Side, and adjacent to the West half of the Southwest quarter of Block 2, 11, in Monticello's Northern Addition to the City of Albany, Oregon; also on Calapooia Street on the West side of and adjacent to said West half of the Southwest quarter of said Block 2, 11, in Monticello's Southern Addition to the City of Albany, Oregon, was and is the sum of \$125.76.

Section 2. That there are and there is hereby assessed upon the said West half of the Southwest quarter of Block 2, 11, in Monticello's Northern Addition to the City of Albany, Oregon, for sidewalk construction the sum of \$35.76 and that the same be and is hereby made a lien upon said premises until the full payment thereof and the Recorder of the City of Albany, Oregon, is hereby ordered and directed to immediately enter a statement of the said assessment and lien upon the title with the name of the owner of said West half of the Southwest quarter of Block 2, 11, in Monticello's Northern Addition to the City of Albany, Oregon, with a lien in the name of City of Albany of the City of Albany as provided by the Charter of said city, and that the Recorder shall forthwith give notice in writing as provided in Section 223 of the Charter of the City of Albany to the owner or reputed owner of said real property.
