

ORDINANCE NO. 701

Ord 701

An ordinance declaring a surtise on account of the construction of a lateral sewer to Block 3 in the Eastern Addition to the City of Albany, Oregon and into Baker Street to connect to main sewer on Baker Street in & directing the Recorder of the City of Albany to place to the credit of the several owners of the various parcels of real estate within said Block 3 Eastern Addition to the City of Albany, Oregon a several and interest of \$1000.00 in the City of Albany, Oregon for making such improvement to the proportionate share of such amount.

The Provisions of the City of Albany Ordinance follows:

Section 1. A surtise of 5.15833 per cent is hereby ascertained and declared to exist upon the completion of the contract entered into by and between the City of Albany, Oregon, and W. C. Wharen for the construction of lateral sewer through Block 3 in the Eastern Addition to the City of Albany, Oregon, and into Baker Street to connect to main sewer on Baker Street and in favor of the several owners of the various parcels of real estate within said Block 3, heretofore assessed for making such improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Taxes in the several columns thereof, a credit of 5.15833 percent, based upon the amount herebefore assessed and entered therein to defray the cost of the improvement of said lateral sewer, said surtise to remain in favor of the holders named owners, owners or reputed owners of such various parcels of real estate and in sum as follows, to-wit:

Section 3. All the conditions are such that this ordinance is necessary for the immediate preservation of the public peace, health and safety and in the event of an emergency it shall be lawful for the City of Albany to enforce this ordinance and the full force and effect thereof shall be in full force and effect from the date of its passage by the Mayor.
