An ordinance authorizing the Mayor and Recorder of the City of Albany to enter into a contract with George Gordon for the building and construction of a lateral sewer beginning at the main sewer in Henry Street and running westerly through the center of Block 13, across a sewer Block 14, through the center of Block 14, across Cleveland Street and 48 feet into Block 15 all in Hackleman's Fourth Addition to the City of Albany, Oregon, with vitrified sewer pipe according to the plans, profiles and specifications filed in the office of the Recorder of the City of Albany on the 18th day of May, 1914.

Whereas by resolution 7612 of the City of Albany, Oregon, passed by the council on the 22nd day of May, 1914, it is ordered that a lateral sewer be constructed beginning at the main sewer in Henry Street and running westerly through the center of said Block 13 across Henry Street, through the center of Block 14, across Cleveland Street and 48 feet into Block 15 all in Hackleman's Fourth Addition to the City of Albany, Oregon, said improvement to be made in accordance with the Charter and ordinances of the City of Albany and the plans and specifications and estimates of the City Engineer then on file with the Recorder of the City of Albany, and

Whereas it was provided by ordinance that the Recorder of the City of Albany give notice on bids on the making of said improvement in the manner provided by law and by said ordinance and

Whereas after due notice and advertisement for bids made and given by the Recorder of the City of Albany according to said ordinance on the 22nd day of July, 1914 George Gordon presented to the council of said city his bid, on making said improvement, which bid was made in due form and in conformity with all the conditions imposed by law and by said ordinance, he was in compliance with the law that he should furnish all material and implements and labor for the work necessary to make the above described improvement for the sum of \$5074.00 and

Whereas there is no other bidder for said proposed work and said bid was the lowest and best and the same is hereby

It is the order of the City of Albany to accept the same as follows:
Section 1. That the said bid be accepted and the same be

or said improvement is and the same is hereby accepted and the Mayor and Recorder of the City of Albany are hereby authorized to enter into a contract in writing with the said George Gordon with the terms of said improvement as aforesaid on the part of the City of Albany, upon the terms and conditions in said ordinance, a copy of which will give details as mentioned. Said contract shall provide that the work on said sewer shall commence within ten days after the signing of said contract and be prosecuted with such vigor that all the work embraced in said contract shall be entirely completed on or before the first day of October, 1914, and the City of Albany, Oregon, shall be deemed to have arranged to the extent of \$2.00 per day - maximum amount - every day the work is delayed beyond said specified time.

Said contract shall further provide that the said George Gordon shall promptly advise, make payment to all persons supplying to the said George Gordon, labor or material for the prosecution of the hereinabove described work and that the said George Gordon shall not permit any lien or claims to be filed or prosecuted against the City of Albany for or on account of any material or labor furnished on the said work.

The said George Gordon shall furnish a penal bond in the sum of \$200.00 with good and sufficient sureties to be approved by the Mayor of the City of Albany, to secure the performance of all the obligations of said contract on the part of the said George Gordon and his heirs, assigns, agents, or assigns for labor, work or material on the part of any person arising out of said contract.
