

Lawling, Albany, Oregon

This Street except to its intersection with the Dutch boundary line of Fairbank Street in Center Addition to the City of Albany, if extended westerly in a direct line; thence easterly along said Dutch boundary line of Fairbank Street and its extension to its intersection with the Eastern boundary line of the Donation Land Claim of Emma Corfield, Grade No. 1, thence northerly along said eastern boundary line of the Donation Land Claim to the Northwest corner of Block 13 in the Northern Addition to the City of Albany; thence westerly and parallel with the eastern boundary line of the Dutch tract to the Northwest corner of Block No. 105 in the Northern Addition to the City of Albany, thence northerly along the east line of Elm Street to the north line of North Street in the City of Albany; thence easterly along said north line of North Street to the Northwest corner of Block 6 in the City of Albany, thence North 90 West to the place of beginning.

commencing at eight o'clock in the morning and ceasing at eight o'clock in the evening of the same day without closing the polls.

Section 2. That all special elections shall be conducted except as herein otherwise provided both within said city and within its territory in the same manner as general elections are conducted in said city.

Section 3. That the following places are hereby designated as the places at which the polls will be opened and special elections in the several wards:

- Punty Recorder's office, or First Ward
- City Recorder's office, or Second Ward
- Hotel Building, east side of Fairbank Street between Second and Third Streets, or Third Ward.

Section 4. The following place is hereby designated as the place at which the polls will be open for special elections in the entire municipal territory, to-wit:
