

his Ordinance to ascertain and determine the probable cost of certain improvements which the Council of the City of Albany, Oregon, has determined in Resolution No. 67, adopted by said Council on the 28th day of April, 1915, to make on Main Street from the north line of Water Street to the north line of Fourth Street, to ascertain, assess, determine and declare the proportionate share of such probable cost of such improvements, and Main Street that is assessed upon each lot or part thereof adjacent to said part of Main Street to be so improved, to direct the Recorder of said City to enter a statement of such assessment in the Book of City Liens as provided in the charter of said City.

Whereas, on the 27th day of March, 1915, the Council of the City of Albany, Oregon, duly adopted a resolution requiring the City Engineer of said City to make plans and specifications for the improvement of Main Street from the north line of Water Street to the north line of Fourth Street in the following manner, to-wit:

- First: By grading said street to the proper subgrade.
- Second: By paving the roadway of said street full width with full intersection with asphaltic concrete pavement on an asphaltic concrete foundation.
- Third: By laying and constructing asphaltic concrete curbs.
- Fourth: By constructing catch basins.
- Fifth: By constructing inlets.
- Sixth: By laying vitrified sewer pipes.
- Seventh: By laying sub-drains etc.

and for estimates of the work to be done on the said portion of Main Street and the probable cost thereof and requiring that such plans, specifications, estimates and probable cost be filed in the Recorder's office of said City, said resolution being an Ordinance "Resolution No. 6" and adopted on the 27th day of March, 1915; and

Whereas, the City Engineer of said City of Albany, pursuant to said Resolution No. 6, made plans, specifications and estimates as directed by said resolution for the improvement of said Main Street in the manner specified in said Resolution No. 6, and filed said plans, specifications and estimates in the Recorder's office in said City on the 28th day of April, 1915; and

Whereas, the said Council on the 28th day of April, 1915, by Resolution No. 69, duly adopted by said Council, determined and resolved that it deemed it expedient and that said Council proposed to improve Main Street from the north line of Water Street to the north line of Fourth Street in the manner provided in said Resolution No. 6; and

Whereas, in and by said Resolution No. 17, adopted as above said by the Council, the Recorder of said city was duly ordered and directed by said Council to give notice of said proposed improvement of said Main Street from the south line of Water Street to the south line of Fourth Street as provided by the charter of said City; and

Whereas, the Recorder in pursuance of said order and direction of the Council, said City of Albany did duly give notice of said proposed improvement of said Main Street in the manner provided by the charter of said City; and

Whereas, the said Council in and by said Resolution No. 19 ascertained and determined the total probable cost of making said improvement of said Main Street to be paid by the owners of the real property adjacent to said portions of said Main Street to be improved as specified in said Resolution No. 17 to be the sum of \$5,916.47.

Therefore

The People of the City of Albany do Ordain As Follows:

Section 1. That Main Street in the City of Albany, Oregon, from the south line of Water Street to the south line of Fourth Street, shall be improved as follows:

- First: By grading said street to the proper subgrade.
- Second: By paving the roadway of said street full width with firm intersections with asphaltic concrete pavement on an asphaltic concrete foundation.
- Third: By raising and constructing asphaltic concrete curbs.
- Fourth: By constructing catch basins.
- Fifth: By connecting into inlets.
- Sixth: By raising sidewalk curbs.
- Seventh: By raising curb & base.

All in accordance with said Resolution No. 17 and the plans and specifications for said improvement filed by the City Engineer with the Recorder of said City of Albany on the 25th day of April, 1914.

Section 2. That the probable cost of making said improvement of said Main Street in the City of Albany, Oregon, from the south line of Water Street to the south line of Fourth Street in the manner here before determined by the Council of the said City of Albany in and by said Resolution No. 17, with asphaltic concrete pavement

ment to be paid by the owners of the real property adjacent to said portion of said Main Street is hereby declared to be the sum of \$5,976.47.
 Section 3. That the proportionate share of said probable cost of said improvement of said Main Street assessed upon each lot or part thereof adjacent to said part of said Main Street to be improved as aforesaid and as determined by said Council in and by said Resolution No. 19 is hereby ascertained and declared to be the sum set and placed in resolution aforesaid under the separate description of each of such lots or parts thereof as follows:
