

And the same declares a surplus on account of the construction of a lateral sewer by C. M. Quartley, beginning at the manhole in Oak Street sewer between Water and First Streets in the City of Albany, Oregon, and running thence westerly across Oak Street and through the center of Block 8, the common Third Addition to the City of Albany, Oregon, and to within 40 feet of the east line of Sherman Street in the City of Albany, Oregon, a distance of 275 feet, and directing the Recorder of the City of Albany, Oregon, to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed and entered of record in the Book of Citations in the City of Albany, Oregon, for making such improvement, their proportionate share of such surplus.

The People of the City of Albany Do Ordain As Follows:

Section 1. That a surplus of 8.0% percent is hereby ascertained and declared to exist upon the completion of the contract entered into by and between the City of Albany, Oregon, and C. M. Quartley for the construction of a lateral sewer beginning at the manhole in Oak Street sewer between Water and First Streets in the City of Albany, Oregon, and running thence westerly across Oak Street and through the center of Block 8 of the common Third Addition to the City of Albany, Oregon, and to within 40 feet of the east line of Sherman Street in the City of Albany, Oregon, a distance of 275 feet, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for making such improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Book of Citations in the surplus column thereof a credit of 8.0% percent based upon the several amounts heretofore assessed and entered therein to defray the cost of the improvement of said lateral sewer, said surplus being in favor of the following named persons, owners or reputed owners of such parcels of real estate and in sums as follows, to-wit:
