

Law Or Lawance cancelling the assessment heretofore made against certain property there buried by Grace Presbyterian Church of Albany Oregon.

Whereas, by virtue of obnoxious proceedings heretofore taken by the Council of the City of Albany, Grace Presbyterian Church of Albany, Oregon, was assessed to benefits accruing to Lot 16 in Jones' addition to said City of Albany for an account of the improvement by said City of Albany of Main Street from the south line of Water Street to the south line of Third Street, and

Whereas, the Grace Presbyterian Church of Albany, Oregon, in consideration of said City of Albany giving said Grace Presbyterian Church of Albany, Oregon, free and harmless roadway and all charges for the improvement of said Main Street in front of the herein after described real property, made, executed and delivered to said City of Albany and said City of Albany received from said Grace Presbyterian Church of Albany, Oregon, a deed conveying to said City of Albany the rights, title and easement to said use and maintain as a street line from the described property, to wit:

Beginning at the northwest corner of Lot Sixteen (16) in Jones' addition to the City of Albany, Oregon, and running from thence easterly along the eastern boundary line of Main Street a distance of 17.5 feet, more or less, to the northern boundary line of Fourth Street, extended thence easterly along the said northern boundary line of said Fourth Street extended a distance of 38 feet, more or less, to an intersection with the northeastern boundary line of said Lot Sixteen (16) in said Jones' addition to the City of Albany, Oregon; thence northwesterly along the said northeastern boundary line of said Lot Sixteen a distance of 12.5 feet, more or less, to the place of beginning, all in said County, Oregon!

Therefore

The People of the City of Albany do Ordain as Follows:

Section 1. That the Recorder of the City of Albany be and he is hereby directed to cancel so much of the assessment heretofore made and entered against the Grace Presbyterian Church for benefits accruing to Lot 16 in Jones' addition to the City of Albany, Oregon, for an account of the improvement by said City of Albany of Main Street from the south line of Water Street to the south line of Third Street, as was properly chargeable for benefits accruing to property adjacent to the following described portion of said Main Street, to wit: commencing at the

northwest corner of Lot Fifteen in Jones' Addition to the City of Albany, Oregon, and running thence southwesterly along the eastern boundary line Main Street a distance of 17.6 feet, more or less, to the northern boundary line of Fourth Street extended, to-wit; the sum of \$57.44.

Section 2. That the Recorder of the City of Albany be and he is hereby directed to enter in the Hocket of Debts due to the credit of said Grace Presbyterian Church of Albany, Oregon, a credit for the amount set forth in Section 1 of this ordinance, real the approximate amount heretofore credited on said line on account of surplus, to-wit; a credit for the sum of \$60.30.
