

and On Finance cancelling the assessment heretofore made against certain property then owned by Grace Presbyterian Church of Albany, Oregon.

Whereas, by virtue of appropriate proceedings heretofore taken by the Council of the City of Albany, Grace Presbyterian Church of Albany, Oregon, was assessed for benefits accruing to Lot 16 in Jones' Addition to said City of Albany for and on account of the improvement by said City of Albany of Main Street from the south line of Water Street to the south line of Tenth Street, and

Whereas, said Grace Presbyterian Church of Albany, Oregon, in consideration of said City of Albany having paid Grace Presbyterian Church of Albany, Oregon, reasonable damages, expenses and all charges for the improvement of said Main Street in front of the hereinafter described real property, made, executed and delivered to said City of Albany and said City of Albany accepted from said Grace Presbyterian Church of Albany, Oregon, a deed conveying to said City of Albany the right, title and easement to board use and maintain as a street line for the above described property, to-wit:

Beginning at the northwest corner of Lot Sixteen (16) in Jones' Addition to the City of Albany, Oregon, and running from thence southerly along the eastern boundary line of Main Street a distance of 17.5 feet, more or less, to the northern boundary line of Fourth Street, extended thence easterly along the said northern boundary line of said Fourth Street extended a distance of 38 feet, more or less, to an intersection with the northeastern boundary line of said Lot Sixteen (16) in said Jones' Addition to the City of Albany, Oregon; thence southerly along the said northeastern boundary line of said Lot Sixteen a distance of 42 feet, more or less, to the place of beginning, all in said County, Oregon.

Therefore

The People of the City of Albany do Ordain as Follows:

Section 1. That the Recorder of the City of Albany be and he is hereby directed to cancel so much of the assessment heretofore made and entered against the Grace Presbyterian Church for benefits accruing to Lot 16 of Jones' Addition to the City of Albany, Oregon, for and on account of the improvement by said City of Albany of Main Street from the south line of Water Street to the south line of Tenth Street, as was properly chargeable for benefits accruing to property adjacent to the following described portion of said Main Street, to-wit: Beginning at the

Lawling, Albany, Oregon

is out west corner of Lot Fifteen in Jones' Addition to the City of Albany, Oregon, and running thence southerly along the eastern boundary line of Main Street a distance of 17.6 feet, more or less, to the northern boundary line of Fourth Street extended, to-wit: the sum of \$57.24.

Section 2. That the Recorder of the City of Albany be and he is hereby directed to enter in the Docket of Citizens to the credit of said Grace Presbyterian Church of Albany, Oregon, a credit for the cancelled by Section 1 of this ordinance, and the appropriate amount heretofore credited on said lien on account of surplus, to-wit: a credit for the sum of \$20.30.
