

ORDINANCE NO. 359

AN ORDINANCE TO AMEND SECTION 1 OF ORDINANCE NO. 628 ENTITLED, "AN ORDINANCE TO AMEND SECTION 1 OF ORDINANCE NO. 417 ENTITLED, 'AN ORDINANCE TO PROVIDE FOR THE PREVENTION OF FIRES AND THE PROTECTION OF PERSONS AND PROPERTY ENDANGERED THEREBY; AND TO ESTABLISH AND DEFINE THE FIRE LIMITS OF THE CITY OF ALBANY; AND TO REPEAL ALL ORDINANCES IN CONFLICT THEREWITH; PASSED BY THE COUNCIL OF SAID CITY ON THE 22, DAY OF MAY, 1906 AND APPROVED BY THE MAYOR MAY 24, 1906", PASSED BY THE COUNCIL MARCH 12TH, 1913 AND APPROVED BY THE MAYOR MARCH 12, 1913,

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That Section 1 of Ordinance No. 628 entitled, "An Ordinance to amend Section 1 of Ordinance No. 417 entitled, 'An Ordinance to provide for the prevention of fires and the protection of persons and property endangered thereby; and to establish and define the fire limits of the City of Albany; and to repeal all ordinances in conflict therewith', passed by the Council of said City on the 22nd day of May 1906 and approved by the Mayor May 24, 1906", passed by the Council March 12, 1913 and approved by the Mayor March 12, 1913 be and the same is hereby amended so as to read as follows; to-wit: Section 1. The fire limits of the City of Albany shall be bounded by a line commencing where the center line of Water Street intersects the center line of Washington Street and running thence Southerly following the center line of Washington Street to a point equally distant from the center line of Second Street and Third Street, thence Easterly parallel with the center line of Second Street to the center of Ferry Street at a point equally distant from Second Street and Third Street, thence Southerly along the center of Ferry Street to the center line of Third, thence Easterly along the center line of Third Street to a point in the center of said Third Street 100 feet Westerly from the West line of Lyon Street; thence Southerly parallel with the West line of Lyon Street and 100 feet Westerly from said line to a point on the middle line of Fifth Street which is 100 feet West from the West line of said Lyon Street; thence Easterly along the center line of said Fifth Street to a point on the center line of said Fifth Street 100 feet Easterly from the East line of said Lyon Street; thence Northerly parallel with the East line of Lyon Street and 100 feet therefrom to the center of Second Street, thence Easterly following the center line of Second Street to its intersection with the center line of Baker Street, thence Northerly following the center line of Baker Street to a point equally distant from the center lines of First Street and Water Street, thence Westerly parallel with the center line of First Street to the center line of Lyon Street, thence Northerly following the center line of Lyon Street, to the center line of Water Street, thence Westerly following the center line of Water Street to the place of beginning.
