

## ORDINANCE No. 287

AN ORDINANCE TO ASCERTAIN AND DETERMINE THE PROBABLE COST OF CONSTRUCTING A LATERAL SEWER WHICH THE COUNCIL OF THE CITY OF ALBANY, OREGON, HAS DETERMINED BY RESOLUTION NO. 39, ADOPTED BY THE COUNCIL ON THE 10th day of MAY, 1916, BEGINNING AT THE LAMP HOLE AT THE EASTERN END OF THE LATERAL SEWER NOW IN PLACE IN THE SANTIAM ROAD AND EXTENDING IN A SOUTHEASTERLY DIRECTION ALONG SAID SANTIAM ROAD, A DISTANCE OF 320 FEET IN HACKLEMAN'S HEIRS FIRST ADDITION TO THE CITY OF ALBANY, OREGON, TO ASCERTAIN, ASSESS, DETERMINE AND DECLARE THE PROPORTIONATE SHARE OF SUCH PROBABLE COST OF SUCH IMPROVEMENT THAT IS ASSESSED UPON EACH LOT OF PART THEREOF, OR PARCEL OF LAND ADJACENT TO SAID IMPROVEMENT, TO DIRECT THE RECORDER OF SAID CITY TO ENTER A STATEMENT OF SUCH ASSESSMENTS IN THE DOCKET OF CITY LIENS, AS PROVIDED BY THE CHARTER OF SAID CITY.

WHEREAS, on the 26th day of April, 1916, the Council of the City of Albany, duly adopted a resolution requiring the City Engineer of said City to make plans and specifications for the construction of a lateral sewer beginning at the lamp hole at the Eastern end of the lateral sewer now in place in the Santiam road and extending in a Southeasterly direction along said Santiam Road, a distance of 320 feet, in Hackleman's Heirs First Addition to the City of Albany, and for the estimate of the work to be done and the probable cost thereof, and requiring such plans, specifications and probable cost to be filed in the office of the Recorder of the City of Albany, on the 10th day of May, 1916, and said resolution being endorsed "Resolution No. 38", approved April 26th, 1916, and

WHEREAS the City Engineer of said City of Albany pursuant to said Resolution No. 38, made plans, specifications and estimates as directed by said Resolution for the construction of said sewer in the manner specified in said Resolution No. 38, and filed said plans, specifications and estimates in the Recorder's office in said City on the 10th day of May, 1916, and

WHEREAS the said City Council on the 10th day of May, 1916, by resolution No. 39 duly adopted by said Council, determined and resolved that it deems it expedient, and that said Council proposes to construct said lateral sewer beginning at the lamp hole at the Eastern end of the lateral sewer now in place in Santiam Road, and extending in a Southeasterly direction along said Santiam Road, a distance of 320 feet in Hackleman's Heirs First Addition to the City of Albany, Oregon, as provided by

the Charter of said City of Albany, and

WHEREAS the Recorder in pursuance of said order and direction of the Council of said City of Albany did duly give notice of said proposed improvement in the manner provided by the Charter of said City, and

WHEREAS the said Council in and by said resolution No. 39, ascertained and determined the total probable cost of making said improvement to be paid by the owners of the real property adjacent to said improvement as mentioned in said resolution No. 39 to be the sum of \$133.89, and the total probable cost of making said improvement to be \$168.85.

T H E R E F O R E

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That an 8-inch vitrified terra cotta sewer shall be constructed beginning at the lamp hole at the Eastern end of the lateral sewer now in place in the Santiam Road and extending in a Southwesterly direction along said Santiam Road a distance of 320 feet in Hackleman's Heirs First Addition to the City of Albany, Oregon, in accordance with said Resolution No. 39, and the plans and specifications for said improvement filed by the City Engineer with the Recorder of said City of Albany on the 10th day of May, 1916.

Section 2. That the probable cost of making said improvement in the manner heretofore determined by the Council of said City of Albany, in and by said Resolution No. 39, is hereby declared to be the sum of \$ 168.85, and the probable cost of said improvement to be paid by the property adjacent and especially and particularly benefited thereby is the sum of \$133.89.

Section 3. That the proportionate share of said probable cost of said improvement assessed on each lot or part thereof, or parcels or tracts of land adjacent to said improvement as aforesaid, and as determined by said Council in and by said Resolution No. 39, is hereby ascertained and determined to be the sum set and placed immediately after the separate description of said lots or parts thereof, of parcels or tracts of land as follows:

Section 4. That the recorder of the City of Albany, Oregon, is hereby ordered and directed to immediately enter a statement of the assessment made and determined by this ordinance, together with the names of the respective owners of such lot, or parts thereof, or tracts or parcels of land adjacent to said improvement, hereinabove described, in the Docket of City Liens of the said City of Albany, as provided in the Charter of said City.
