ORDINANCE NO. 930

AN ORDINANCE TO AMEND ORDINANCE NO. 633 OF THE CITY OF ALBANY, OREGON, ENTITLED "AN ORDINANCE REGULATING THE CONSTRUCTION, ERECTION, RAISING, LOWERING, ALTERATION, REPAIR AND USE OF BUILDINGS AND TO PROVIDE FOR PROTECTION AGAINST FIRE AND TO REPEAL ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT WITH THE PROVISIONS OF THIS ORDINANCE", PASSED BY THE COUNCIL APRIL 28, 1913, and APPROVED BY THE MAYOR APRIL 29, 1913.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That ordinance number 633 of the City of Albany, Oregon, entitled "An Ordinance regulating the construction, erection, raising, lowering, alteration, repair and use of buildings and to provide for protection against fire and to repeal all ordinances and parts of ordinances in conflict with the provisions of this ordinance", passed by the Council April 28, 1913, and approved by the Mayor April 28, 1913, be and the same is hereby amended by adding another section thereto which shall be known and designated as Section 105, and which said section shall read as follows, to-wit:

Section 105. It shall be lawful for any person, firm or corporation to erect any open shed within the fire limits of the City of Albany of wooden material *that the roof thereof shall be covered with fire proof material provided* provided, also that no such shed so constructed shall be enclosed; provided also that no open shed shall be constructed in the manner designated by this section if the cost thereof shall exceed the sum of \$75.00; and provided further that the person, firm or corporation desiring to build such shed shall first obtain a permit therefor from the Committee on Fire and Water of the Council of said City of Albany; provided also that no shed shall be so constructed within 50 feet distance of any street within said city.
