AN ORDINANCE PROVIDING FOR THE TIME AND MANNER OF IMPROVING TENTH STREET FROM THE EAST LINE OF CALAPOOIA STREET. PROVIDING HOW THE COST OF SUCH IMPROVEMENT SHALL BE PAID, THE PENALTY OR DAMA AGE TO THE CITY OF ALBANY BY THE EXERCH OR PERSONS MAKING SUCH IMPROVEMENT, IF THE SAME SHALL NOT BE COMPLETED WITHIN THE TILDE AGREED UPON AND THE SIVING OF A GOOD AND SUFFICIENT BOID FOR THE FAITHFUL PR. FORMANCE OF THE WORK OF SUCH IMPROVEMENT OF SAID PART OF SAID STREET, AND PROVIDING FOR THE SIVING BY THE RECORDER OF SAID CITY OF PROPER BIDS FOR THE COM PLETION OF SUCH IMPROVEMENT.

THE PROPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That Tenth Street from the Rest line of Elm Street to the East line of Galapcois Street shall be improved in the following manner, to-wit:

First: By grading said street to the proper grade.

Second: By graveling said street. Third: By constructing inlete. Fourth: By laying sever pipe.

mances of the City of Albany, Oregon and the plans, specifications and estimates of the City Engineer of said City for the improvement of said street, "iled in the office of the Recorder of said City of Albany, Oregon on the 22nd day of June, 1921 endorated "Engineer's plans and so-edifications for the improvement of Tenth Street from the East line of Elm Street to the East line of Calapoois Street and the estimate of the work to be ione on said street and the probable cost thereof. "The cost of said improvement of said portion of Tenth Street shall be paid out of the funds collected and arisin upon and out of the assess ment hereafter to be made, ascertained and declared by the Council of the City of Albany, on the lots and parts of lots adjacent to said portion of said Tenth Street so to be improved, and especially and particularly benefited thereby, as provided by the charter of said city.

The said improvement of said portion of said Tenth Street shall be complated by the 13th day of October, 1921.

All bids for the making of said improvement of said strest deemed unreason able by the Council of the City of Albany may be rejected.

Any firm, person or corporation with whom any contract may be entered into by the City of Albany for the making of said improvement, shall before communcing said improvement, and at the time of signing such contract, make, execute and deliver to said City a good and sufficient bond with good and sufficient surety, in the sum of one Thousand dollars for the faithful performance of such contract.

Section 2. If the firm, person of corporation entering into any contract with the said City of Albany to make said improvement of said Tenth Street shall not complete the same within the time mentioned and specified in said ontract, said city shall be deemed to suffer damages on account thereof to the amount of 10.00 per day for each and every day the completion of said work is delayed be-

yond the time stated in such contract, which amount shall be paid by such contractor doing the work at the completion thereof, unless the time of completion of said improvement is extended by the Council.

Section 5. The Recorder of said City is hereby ordered and directed to immediately give proper notice for bids for the making of said improvement of of said portion of said Tenth Street by publishing such notice ten days in the Albany Evening Herald a daily newspaper published in said city of Albany fully describing in said notice the time and manner of loing the work of said improvement of said Tenth Street.
