

ORDINANCE NO. 1015

AN ORDINANCE, AUTHORIZING AND DIRECTING THE MAYOR AND RECORDER OF THE CITY OF ALBANY, OREGON, TO PURCHASE FIRE HOSE:

WHEREAS, the Committee on fire and water has heretofore reported to the Council of the City of Albany, Linn County, Oregon, that it was necessary in order to properly equip the fire department of the City of Albany, Oregon, that additional fire hose should be purchased.

WHEREAS, thereafter, on the 23rd day of November, 1921 the Council of the City of Albany, Oregon, did duly adopt Resolution No. 32 wherein the Council deemed it necessary that six hundred feet (600 ft.) of two and one-half inch (2½ in) double-jacketed fire hose with or without couplings in fifty foot (50 ft.) lengths be purchased, and it was further provided in and by said resolution that the Recorder of the City of Albany, Oregon, give notice inviting proposals for the purchase of said fire hose.

WHEREAS, in pursuance of the direction contained in said Resolution No. 32 the Recorder of the City of Albany, Oregon, did duly and regularly give notice inviting proposals for the purchase of said fire hose as by the charter, ordinances and said Resolution No. 32 required.

WHEREAS, on the 14th day of December, 1921 at the hour of 8:00 o'clock P.M. in the council chambers of the City of Albany, Oregon, the Council in regular session caused to be opened the bids for said hose

WHEREAS, the bid of Munnell & Sherrill being the lowest bid offered for the sale of said fire hose and equipment, and

WHEREAS, the said Munnell & Sherrill was the lowest and best bidder therefor

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section I: That the Mayor and Recorder by and they are hereby authorized to purchase from Munnell & Sherrill six hundred feet (600 Ft.) of two and one-half inch (2½ in.) double-jacketed fire hose with or without couplings in fifty foot (50 Ft.) lengths at and for the sum of
