AUSTILL FOR AN ORDINANCE Granting unto "Merchants Delivery Company" a corporation, the right and privilege to operate upon the streets of the City of Albany the trucks described herein, and to carry on the business of delivereing merchandise within the City of Albany, Oregon.

THE PROPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOTS:

Delivery Company" a corporation, the right and privilege to operate along and upon the streets, alleys and other public thoroughfares in the City of A lbany, Oregon, the following described motor trucks, to-wit:

1 Ford 4-cylinder delivery truck; weight 1500 pounds; Oregon license, 1922, No. 12372. 1 Ford 4-cylinder delivery truck; weight 1500 pounds; Oregon license, 1922, No. 12373. 1 Ford 4-cylinder delivery truck; weight 1500 pounds; Oregon license, 1922 No. 12374.

and to conduct a general delivery business from the various stores and places of business within the City of A lbany to the patrons of the various stores and place of business, and said described trucks and no others are to be used infonducting this business under this franchise, unless the Council shall upon application by said grantee permit a substitution or addition to eaid equipment.

Section II. That the said grantee shall maintain an office and place of business, and telephone, to be used in connection with said business and for the convenience of the public and the patrons of the said grantee.

Section III. That the said grantee shall in consideration of the privileges herein granted pay the City of A lbany the sum of \$36.00 which said sum may be divided into three equal parts and bepaid in advance.

make any such payment of the amounts herein reserved to the City of Albany when the same becomes due and payable, or shall be twice convicted of violation of the laws of the State of Oregon or the ordinances of the City of Albany, relating to motor vehicles, such failure or convictions shall be deemed sufficient cause for the revocation of this franchise, and the right of revocation for suchoauses is hereby reserved by the City of Albany.

Section V. That the privileges herein granted shall inure to and may be exercised by the said grantee for a period commencing on March 9th. 1922 and ending on January 1st. 1923, unless the same shall be sooner revoked for the causes herein contained.
