

ORDINANCE NO. 1074

A BILL FOR AN ORDINANCE Authorizing and directing the Recorder of the City of Albany to cancel certain street improvement assessment liens upon payment to the City Treasurer of the City of Albany of the sum of Two Hundred Ninety-one and Seventy-nine hundredths Dollars (\$291.79) and filing in the office of the City Recorder of the City of Albany, Oregon, a duplicate receipt therefor.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

That, whereas, the City of Albany has heretofore levied an assessment upon the West half of the Southwest Quarter of Block 110 of Hackleman's Addition to the City of Albany, as the same appears upon the recorded maps and plats of said Addition to said City, the exterior boundary lines of said tract to be parallel with the exterior lines of said block, for the improvement of Second Street, and

Whereas, the owner of the West half of the Southwest Quarter of Block 110 of Hackleman's Addition to the City of Albany desires to satisfy the pro rata assessment against said portion of said Block, and

Whereas, said assessment heretofore levied by the City of Albany, against said Block No. 110 in Hackleman's Addition has been duly entered in the Bond Lien Docket of the City of Albany in Volume 3 at Page 83, thereof, and

WHEREAS, the proportion of said assessment against the West Half of the Southwest Quarter of Block No. 110 in Hackleman's Addition is the sum of Two Hundred Ninety-one and Seventy-nine hundredths Dollars (\$291.79) which said assessment was levied against said real property in the name of Peter Riley.

Section 1. The City Recorder of the City of Albany be and he is hereby authorized upon the payment of the sum of Two Hundred Ninety-one and Seventy-nine hundredths Dollars (\$291.79) to the City Treasurer of the City of Albany, Oregon, and the filing of a duplicate receipt therefor, which said payment shall be made as the amount of the Street assessment due the West half of the Southwest Quarter of Block No. 110 in Hackleman's Addition to the City of Albany, to cancel and mark as satisfied the lien now subsisting in favor of the City of Albany on the West half of the Southwest Quarter of Block No. 110 in Hackleman's Addition to the City of Albany, Oregon.
