## ORDINANCE NO. 1200

A BILL FOR AN CRDINANUE To ascertain, determine and declare a deficit on account of the improvement by C. E. Davis of Eleventh Street from the West line of Elm Street West to the corporate limits of the City of Albany, Oregon, and to ascertain, re-assess, determine and declare the proportionate share of such deficit that is re-assessed upon each lot, or part thereof, adjacent to said Eleventh Street and to direct the Recorder of the City of Albany to enter such deficit so levied in the Docket of City Liens as provided by the charter of said City.

WHEREAS, On the 25 day of July, 1923, the Council of the City of Albany passed Ordinance No. 1089 assessing upon lots, and parts thereof, adjacent to said Eleventh Street, certain amounts for the improvement of said Eleventh Street, and

WHEREAS, The said improvement has been completed and the contrastor's final figures have been filed in the office of the Recorder of the City of albany and the City Council has settled with the contractor for said improvement, and

WHEREAS, It is found by the Council that the sums assessed in said Ordinance upon the separate lots or parts thereof adjacent to said Eleventh Street, as directed in said Ordinance No. 1989 and each of them is insufficient to defray the lost of said improvement, and the total assessment as ascertained, assessed, determined and declared by said Ordinance No. is insufficient to pay the cost of said improvement by the sum of One Hundred Ninty-nine and Ninty-nine hundredths Dollars (\$199.99), and that it is necessary to re-assess the said real property.

THEREFORE, THE FEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. The Council hereby ascertains, determins and declares that there is a deficit in the assessment made in said Ordinance No. 1089, as against the lots and parts of lots adjacent to said Eleventh Street in the sum of One Hundred Ninty-nine and Ninty-nine hundredths Dollars (\$199.99) and that there be and is hereby re-assessed the same to be in excess of the orginal assessment against the several parcels of land, whose owners, or reputed owners, together with the description of the property assessed, as owned by each of them respectively with the amount of such assessment charged to each of them respectively as follows:
