

ORDINANCE No. 1115

A BILL FOR AN ORDINANCE Concerning street improvement assessments heretofore made against Lot 1, in Block 2, in Allen & Hawkins' Addition to the City of Albany, Linn County, Oregon, and directing the Recorder of the City of Albany to prorate the assessments still due and a lien against said property.

WHEREAS, The city of Albany has heretofore levied street improvements assessments against Lot 1, in Block 2 in Allen & Hawkins' Addition to the City of Albany, Linn County, Oregon, in the sum of Two Hundred Forty-four and Seventy hundredths Dollars (\$244.70) and the sum of Seventy-three and Thirty-six Hundredths Dollars (\$73.36) having been paid thereon, leaving a balance due in the sum of One Hundred Seventy-one and Thirty-four Hundredths Dollars (\$171.34) and

WHEREAS, C. M. Westbrook was the owner of the entire lot so assessed, and

WHEREAS, The said C. M. Westbrook has sold a portion of said lot and desires to have pro rated the remaining amount due and assessed against said lot and the whole thereof.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section I. The Recorder of the City of Albany, Linn County, Oregon, be and he is hereby authorized and directed to pro rate the balance due upon the assessment upon Lot 1, in Block 2, in Allen & Hawkins' Addition of the City of Albany, Linn county, Oregon, as follows:

Beginning at the Northeast corner of Lot No. One (1) in Block No. Two (2) in Allen & Hawkins' Addition to the City of Albany, Linn County, Oregon, as the same appears on the maps and plats of said Addition to said City, now on file and of record in the office of the Recorder of Conveyances in and for said County and State, and running thence Southerly along the Eastern boundary line of said Block No. Two (2), 121.23 feet to the Southeast corner of Lot No. Three (3) in said Block No. Two (2); thence Westerly along the Southern boundary line of said Lot No. Three (3) in said Block No. Two (2) 50.69 feet, more or less, to a point midway between the Southeast and the Southwest corners of said Lot No. Three (3); thence Northerly to a point that is midway between the Northeast and the Northwest corners of Lot No. One (1) in said Block No. Two (2); thence Easterly on the Northern boundary line of said Lot No. One (1), 50.00 feet, more or less, to the place of beginning, said premises being the East half of Lots No. One (1), Two (2) and Three (3) in said Block No. Two (2) in said Addition to Albany, Linn County, Oregon.
