

ORDINANCE No. 1168

AN ORDINANCE declaring a surplus on account of the improvement made by W.S. Weaver in the construction of a lateral sewer over the following described premises; to wit:-

Beginning at a point on the Oak Street sewer which would be intersected by the center line running east and west through Block 13 in Hackleman's Third Addition to the City of Albany, Oregon, and Block 2 in Hackleman's Fourth Addition to the City of Albany, Oregon, and running thence to the east line of said Block 2 in said Hackleman's Fourth Addition to the City of Albany, Oregon, a distance of 612 feet,

and directing the Recorder of the City of Albany to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed and entered of record in the Docket of City Liens in said City for making such improvement their proportionate share of such surplus.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$222.74 is hereby ascertained, determined and declared to exist upon the completion of the contract entered into by and between the City of Albany, Oregon, and W.S.Weaver, of Albany, Oregon, for the construction of a lateral sewer over the following described premises, to wit:-

Beginnings at a point on the Oak Street sewer which would be intersected by the center line running east and west through Block 13 in Hackleman's Third Addition to the City of Albany, Oregon, and Block 2 in Hackleman's Fourth Addition to the City of Albany, Oregon, and running thence to the east line of said Block 2 in Hackleman's Fourth Addition to the City of Albany, Oregon, a distance of 612 feet,

and in favor of the owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the making of such improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens, in the surplus column thereof, a credit in favor of the following named persons, owners or reputed owners, of such parcels of real estate in the sums as follows, to wit:-
