ORDINANCE NO. 1177

AN OMDINARCE to smend Section 2 of Ordinance No. 468 of the City of Albany Oregon, entitled "An Ordinance relating to the construction of sidewalks and curbing within certain limits of the City of Albany, and repealing all ordinances and parts of ordinances in conflict herewith," passed by the Council November 10th, 1908, and approved by the Mayor November 11th, 1908, and to repeal all ordinances and parts of ordinances in conflict herewith.

THE PROPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS: -

Section 1. That Section 2 of Ordinance No. 468 of the City of Albany, Orentitled: "An ordinance relating to the construction of sitewalks and egon, entitled: curbing within certain limits of the City of Albany, and repealing all ordinances and parts of ordinances in conflict herewith, passed by the Council November 10th, 1908, and approved by the Mayor November 11th, 1908, as amended by Ordinance No. 619, be and the same is hereby amended to read as follows:

Section 2. The provisions of this ordinance shall apply to the district bounded and described as follows; Beginning at the Southwest corner of Block No. 2 in Hackleman's Third Addition to the City of Albany, Oregon, running thence westerly on the north line of Water Street, to the Southeast corner of Block No. 116 in Hackleman's Addition to said City of Albany, thence southof Block No. 116 in Hackleman's Addition to said City of Albany, thence southerly on the West line of Lafayette Street, to the southeast corner of Block No. 117 in said Addition; thence westerly on the north line of First Street to the east line of Lyon Street; thence northerly on the east line of Lyon Street; thence northerly on the east line of Lyon Street to the Forth line of Water Street; thence westerly on the north line of Water Street to the west line of Washington Street, thence southerly on the west line of Washington Street to the north line of First Street; thence westerly on the north line of First Street to the Wash line of Calapoois Street; thence coutherly on the west line of Calapoois Street to the North line of Third Street; thence westerly on the north line of Third Street to the West line of Vine Street; thence southerly on the west line of Vine Street to the north line of Fourth Street; thence westerly on the north line of Fourth Street to the west line of Walnut Street; thence southerly on the west line of Street to the west line of Walnut Street; thence southerly on the west line of Walnut Street to the north line of Fifth Street; thence westerly on the north line of Fifth Street to the east line of wkon Street; thence southerly on the east line of wkon Street to the north line of Seventh Street; thence westerly on the north line of Seventh Street to the southwest corner of Block No. 41; themes southerly to the southwest corner of Block No. 61; thence westerly to the west line of Cottage Street; thence southerly to the south line of Twelfth Street; thence easterly along the south line of Twelfth Street to the east line of Ellsworth Street; thence northerly on the east line of Ellsworth Street to the north line of Tenth Street; thence easterly on the north line of Tenth Street to the east line of Lyon Street; thence northerly on the east line of Lyon Street; thence northerly on the east line of Lyon Street to the south line of Ninth Street; thence easterly on the south line of Kinth Street to the east line of Main Street; thence northerly on the east line of Main Street to the place of beginning, all in the City of Albany, Linn County, Oregon.

Section 2. All ordinances and parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.
