ORDINANCE NO. 1294

AN ORDINANCE to ascertain and determine the probable cost of certain improvements which the Council of the City of Albany, Oragon, has determined to make in Resolution No. 6, adopted by said Council on the 26th day of march, 1925 on Calapsoia Street, from the south line of Minth Street to the north curb lines of Thirteenth Street in said City; to ascertain, assess, determine and declare the propostionate share of such probable cost of such improvement of said Calapsoia Street that is assessed upon each lot, or part thereof, adjacent to said portion of Calapsoia Street to be so improved; to authorize and direct the Recorder of said City to enter a statement of such assessment in the docket of City Liens as provided by the charter of said City.

VHEMBAS, on the 26th day of Marchi, 1925, the Council of the City of Albapy, Oregon, duly adopted a resolution requiring Charles H. Leonard, Engineer, to prepare and file in the office of the Hecorder of said City on the 26th day of march, 1925, amended plane, specifications and estimates of the propagle cost of making the improvement of Calapsois Street in said City from the south line of Hinth Street to the north curb line of Thirteenth Street in the City of Albany, with a suitable hard surface pavement to be selected and approved by the Council, and

VHHEAS, the said Engineer pursuant to said resolution, made amended plans, specifications and estimates, as directed thereby, for the improvement of said Calapooia Street, and filed the same in the office of the Recorder of said City on the 26th day of March, 1925; and

WHIREAS, the Council of said City on the 22nd day of April, 1925, by Resolution Well duly adopted by said Council, determined and resolved that it deemed it expedient and that the Council proposed to improve Calapooia Etrest from the south line of Minth Street to the north curb line of Thirteenth Street in the City of Albany, Oregon, in the manner provided in said resolution No. 11, and

WHRMSAS, in and by said Resolution No. 11, adopted as aforesaid by the Council, the Recorder of said City was duly oriered and directed to give notice of said proposed improvement of said Calapsoia Street from the south line of Ninth Street to the north curb line of Thirteenth Street, as provided by the charter and ordinances of said City; and

WHENEAB, the Accorder in pursuance of said orier and direction of the Council of said City of Albany, iid duly give notice of said proposed improvement of said Calapcoia Street in the manner provided by said sesolution and the charter and ordinances of said City, and

WHEREAS, the said Council in and by said mesolution No. 11, ascertained and determined the total probable cost of making said improvement of said Calapoola Street, to be paid by the owners of the real property adjacent to said portion of said Calapoola Street, to be improved as specified in said Resolution No. 11 to be the sum of 13,944 and 97/100 DOLLARS.

WHEREAS, by ordinance No. 1180, after due notice for the time and in the manner provided by law the bid of Guy F. Pyle for the making of the said improvement of said portion of Calapsoia Street was accepted, and the Mayor and Recorder of the City of Albany were thereby authorized to enter into a contract with Guy F. Pyle for the making of said improvement in accordance with said Bid, with Warrenite Bitulithic pavement, and in other respects in accordance with said Resolution No. 11.

THEREFORK THE PROPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That Calaposia Street in the City of Albany, Oregon, from the south line of Hinth Street to the north curb line of Thirteenth Street shall be improved as follows:

lst. By grading said street to the proper sub-grade,
2nd. By paving the roadway of said street full width with full interesections (except as noted in the plans and specifications) with
warrenite Bitgulithic pavement

By laying and constructing pavement headers, By constructing concrete curbs wherever necessary. 4th.

5th. By constructing concrete curbs wherever necessary.

5th. By constructing catch basins and inlets,

6th. By laying vitrified sewer pipes,

7th. By tapping the main sever.

All in accordance with said resolution He, 11 and the plans and specifications for said improvements filed by Charles H. Leonard, City Engineer, with the hecorder of said City of Albany on the 26th day of March, 1925.

Section 2. That the probable cost of making said improvement of said Calapsois Street from the south line of Hinth Street to the north surb line of Thirteeth Street in said City in the manner heretofore determined by the Council of said Cityand in and by said resolution No. 11, to be paid by the owners of the real property adjacent to said portion of Calapsois Street is hereby declared to be the sum of \$13,944.97.

Section 3. That the proportionate share of said probable cost of said im-provement of said Calapsois Street, assessed upon each lot or part thereof, adja-cent to said portion of Calapsois Street to be improved as afforced and as de-
