AN ORDINANCE declaring a surplus on account of the improvement by C.E. Davis of Second Street from the west line of Cleveland Street to the west line of Geary Street, in the City of Albany, Oregon, and directing the hecorder of said City to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed and entered of record in the Docket of City Liens in the City of Albany, Oregon, for making such improvement, their proportionate share of such surplus.

THE PROPER OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$11.79 is hereby ascertained and declared to exist upon the completion of the contract entered into between the City of Albany, Oregon, and C.E.Davis for the improvement of Second Street from the west line of Cleveland Street to the west line of Geary Street, in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for making such improvement.

Section 2.
