

ORDINANCE NO. 1324.

AN ORDINANCE granting Verne C. McDowell the right to erect three ornamental posts for street lighting purposes on the sidewalk adjacent to the Schmitt-Hunt building, situated on the south-east quarter of block 17, in the city of Albany, Oregon, and to connect the same with conduits and electric wiring.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That Verne C. McDowell be, and she is hereby, granted the right and privileged of erecting three ornamental posts for street lighting purposes on the sidewalk adjacent to the Schmitt-Hunt building, situated on the southeast quarter of block 17 in the City of Albany, Oregon, and to connect the same with conduits and electric wiring for illuminating purposes:

Provided that the installation of the equipment aforesaid shall be done at the expense of the said Verne C. McDowell, and without cost or expense to the City of Albany;

Provided further that the said Verne C. McDowell shall replace the streets, alleys, pavement and sidewalks in good condition and repair immediately after the installation of the installation of the equipment aforesaid;

Provided further that all such posts, conduits, wiring, fixtures and other devices used in connection therewith shall be subject to the approval of the Council of said City of Albany, and the same shall be installed according to such specifications as the Council may prescribe;

Provided further that the Council hereby reserves the right to relocate such posts at any time it may deem it expedient.

Section 2. Upon the installation of the equipment aforesaid and its approval and acceptance by the Council, the Council shall provide electric current for lighting the same, and shall keep in repair and maintain the same at the expense of the City of Albany, and upon its acceptance such equipment and the whole thereof shall be deemed to be the property of said City.

Section 3. This ordinance shall not become effective unless a written acceptance of the terms thereof shall be filed with the recorder of said City within thirty days from the date of its approval by the Mayor.


