AN ORDINANCE authorizing, directing and licensing the Hayor and Recorder of the City of Albany, Oregon, to make, execute and deliver to Al. Sternberg, on behalf of said City, a deed of conveyance of a certain tract of land belonging to the City of Albany, Oregon.

WERRAS, by Resolution Mr. 34 the Gounda nucleorized and directed the Mayor of the City of Albany to advertise and sell the following described real property belonging to saudcity, to-wit:
