

ORDINANCE NO. 1243

AN ORDINANCE DECLARING A SURPLUS on account of the construction of a lateral sewer by John Olson, beginning at the manhole in the Cottage Street Trunk Sewer, which is 26 feet easterly from the southeast corner of lot 1 in block 4 in Linnmont Addition to the City of Albany, Oregon, and running thence westerly through the center of said block a distance of 220 feet to the southeast corner of lot 5 in said block, and directing the Recorder to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed and entered of record in the docket of city liens of the City of Albany, Oregon, for the making of such improvement, their proportionate share of such surplus:

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of Sixty-six Dollars, ^(\$66.00) is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into by and between the City of Albany, Oregon, and John Olson, for the construction of a lateral sewer, beginning at the manhole in the Cottage Street Trunk Sewer, which is 26 feet easterly from the southeast corner of lot 1 in Block 4 in Linnmont Addition to the City of Albany, Linn County, Oregon, and running thence westerly through the center of said Block a distance of 220 feet to the southeast corner of lot 5 in said block, and in favor of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the docket of City Liens of the City of Albany, Oregon, in the surplus column thereof the sum of (\$66.00) Sixty-Six Dollars, based upon the several amounts heretofore assessed for making such improvement and entered therein to defray the cost of the construction of said lateral sewer, said surplus being in favor of the various owners, or reputed owners, of the various parcels of real estate, and in the following sums to-wit:
