

ORDINANCE NO. 1312

AN ORDINANCE declaring a surplus on account of the construction of a lateral sewer by Fred H. Slate, beginning on the Cottage Street trunk sewer on Albany-Corvallis Rd. in the City of Albany, Oregon, 16 feet southerly from the southeast corner of lot 1 in block 3 in Albany Heights Addition to Albany, Oregon, and running thence northerly 834 feet through the center of blocks 3 and 4 of said Albany Heights Addition to the northeast corner of lot 7 in block 4 in said Addition, and directing the Recorder to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed and entered of record in the docket of City Liens of the City of Albany, Oregon, for the making of such improvement, their proportionate share of such surplus;

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of Fifty Four and 81/100 Dollars (\$54.81) is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into by and between the City of Albany, Oregon, and Fred H. Slate for the construction of a lateral sewer, beginning on the Cottage Street trunk sewer on Albany-Corvallis Rd. in the City of Albany, Oregon, 16 feet southerly from the southeast corner of lot 1 in block 3 in Albany Heights Addition to Albany, Oregon, and running thence northerly 834 feet through the center of blocks 3 and 4 of said Albany Heights Addition to the northeast corner of lot 7 in block 4 in said Addition, and in favor of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the docket of City Liens of the City of Albany, Oregon, in the surplus column thereof the sum of Fifty Four and 81/100 Dollars (\$54.81) based upon the several amounts heretofore assessed for making such improvement and entered therein to defray the cost of construction of said lateral sewer, said surplus being in favor of the various owners, or reputed owners, of the various parcels of real estate, and in the following sums, to-wit: RIECKERS, H.A. and EDITH. -Lot 1 in block 3, Albany Heights Add. to Albany, Or.


