ORDINANCE No. 1330

AN ORDINANCE to ascertain and determine the probable cost of certain improvements which the Council of the City of Albany, Oregon, has determined to make in Resolution No. 26, adopted by said Council on the 8th day of October, 1930, on Park Terrace Street from the south line of Clackamas Street to the north line of Fifteenth Street, in the City of Albany, Oregon; to ascertain, assess, determine and declare the proportionate share of such probable cost of such improvement of said portion of said street that is assessed upon each lot, or part thereof, adjacent to said portion of Park Terrace Street to be so improved; to authorize and direct the Recorder of said City to enter a statement of such assessment in the Docket of City Liens, as provided by the charter of said City; and declaring an emergency:

WHEREAS, on the 8th day of October, 1930, the Council of the City of Albany, Oregon, duly adopted a resolution requiring Charles H. Leonard, Engineer, to compile and file in the office of the Recorder of said City on the 8th day of October, 1930, plans, specifications and estimates of the probable cost of making the improvement of Park Terrace Street from the south line of Clackamas Street to the north line of Fifteenth Street, in the City of Albany, Oregon, by grading and gravelling the same; and

WHEREAS, said engineer, pursuant to said resolution, made plans, specifications and estimates as directed thereby for the improvement of said Park Terrace Street, and filed the same in the office of the Recorder of said City on the 8th day of October, 1930, and

WHEREAS, the Council of said City on the 8th day of October, 1930, by Resolution No. 26, duly adopted by said Council, determined and resolved that it deemed it expedient and that the Council proposed to improve Park Terrace Street from the south line of Clackamas Street to the north line of Fifteenth Street in the City of Albany, Oregon, in the manner provided in said resolution No. 26, and

WHEREAS, and by said Resolution No. 26 the Recorder of said City was duly ordered and directed to give notice of said proposed improvement of said Park Terrace Street from the south line of Clackamas Street to the north line of Fifteenth Street, in said City, as provided by the charter and ordinances of said city, and

WHEREAS, the Recorder in pursuance of said order and direction of the Council, did duly give notice of said proposed improvement of said Park Terrace Street in the manner provided by said resolution, and the charter and ordinances of said City, and

WHEREAS, the Council in and by said Resolution No. 26 ascertained and determined the total probable cost of making said improvement of said Park Terrace Street, to be paid by the owners of the real property adjacent to said portion of said street to be improved as specified in said Resolution No. 26 to be the sum of \$468.24, and

WHEREAS, by ordinance No. 1338 after due notice and of the tide and in the manner provided by law, the bid of D.L. Ashton for the making of said improvement of said portion of Park Terrace Street was accepted, and the Mayor and recorder of the City of Albany were thereby authorized and directed to enter into a contract with D.L. Ashton for the making of said improvement in accordance with said bid, by grading and gravelling said portion of said Street, and in other respects in accordance with said Resolution No. 26.

WHEREFORE THE PEOPLE OF THE CITY OF ALBANY, OREGON, DO ORDAIN AS FOLLOWS:

Section 1. That Park Terrace Street, in the City of Albany, Oregon, from the south line of Clackamas Street to the north line of Fifteenth Street shall be improved as follows:

1st: By grading said street to the proper sub-grade;

2nd: By surfacing the roadway of said street 16 feet wide with gravel;

All in accordance with said Resolution No. 26 and the plans and specifications for said improvement filed by Charles H. Leonard, City Engineer, with the Recorder of the City of Albany, Oregon, on the 8th day of October, 1930.

Section 2. That the probable cost of making said improvement of said Park Terrace Street from the south line of Clackamas Street to the north line of Fifteenth Street, in said City of Albany, Oregon, in the manner heretofore determined by the Council and in and by said Resolution No. 26, to be paid by the owners of the real property adjacent to said portion of Park Terrace Street, is hereby declared to be the sum of \$468.24.

Section 3. That the proportionate share of said probable cost of said improvement of said Park Terrace Street, tax~~xxxxxxx~~ assessed upon each lot or part thereof, adjacent to said portion of Park Terrace Street, to be improved as aforesaid, and as determined by said Council in and by said Resolution No. 26, is hereby ascertained and declared to be the sum set and placed immediately after the separate description of each of such lots, or parts thereof, as follows:


