**ORDINANCE NO. 1342**

AN ORDINANCE to vacate that portion of Hill Street in the City of Albany lying between Third and Fourth Streets, and being adjacent to blocks 48 and 49 in Hackleman's Addition to said City.

WHEREAS, the Council of the City of Albany by Resolution No. 27, passed by the Council on the 26th day of November, 1930, deemed it expedient and for the best interest of said City that Hill Street lying between Third and Fourth Streets in the City of Albany, and lying between Blocks 48 and 49 in Hackleman's Addition to said City, be vacated, and by said resolution fixed Wednesday, January 14th, 1931, at 7 o'clock P.M. of said day, in the Council Chamber of said City as the time and place for the hearing of objections to the vacation of said portion of said Street, and thereby authorized and directed the Recorder of said City to give notice of the time and place of said hearing as aforesaid, and

WHEREAS, the Recorder of said City on the 28th day of November, 1930, pursuant to said Resolution No. 27 did give due notice of the time and place of the hearing of objections to the vacation of said portion of said street, as in said Resolution set forth, by posting said notice in three of the most public places in the City of Albany, and

WHEREAS, the proof of the notice of said posting, containing a copy thereof, is now on file in the Recorder's office in the City of Albany, Oregon, and

WHEREAS, at a regular meeting of the Council of said City of Albany held on the 14th day of January, 1931, at 7:00 o'clock P.M. of said day, the hearing of objections to the vacation of said portion of said street was continued to the 28th day of January, 1931, at 7 o'clock P.M. in the Council Chamber in said City as aforesaid, and on said 28th day of January, 1931, said hearing was continued to Feb. 11, 1931.

WHEREAS, pursuant to said notice and on this 11th day of February, 1931, at the hour of 7 o'clock P.M. no objections being on file and no one being present to make or present objections to the vacation of said portion of said street as aforesaid, and this being the time and place for the hearing of such objections and objectors, if any there be,

WHEREFORE THE PEOPLE OF THE CITY OF ALBANY  
DO ORDAIN AS FOLLOWS:

Section 1. That Hill Street in the City of Albany, Oregon, lying and being between Third Street and Fourth Street, and being adjacent to Blocks 48 and 49 in Hackleman's Addition to the City of Albany, Linn County, Oregon, be and the same is hereby vacated.
