

# ORDINANCE NO. 1378

AN ORDINANCE levying a tax for the city of Albany, Oregon, upon the current assessment made upon the taxable property of said City for the year 1933, for taxes to become due and payable in the year 1934, and to separately appropriate for each officer, department, building, institution, streets, highways, sewers, parks and other purposes the amount of the taxes so levied.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That there is hereby made, determined, declared and levied taxes in and for the City of Albany, Oregon, based upon the current assessment made ~~upon~~ upon the taxable property therein for the year 1933, said taxes to become due and payable in the year 1934 in sums as follows, to-wit:

Section 3. The Recorder of the City of Albany is hereby directed to immediately notify the County Clerk and County Assessor of Linn County, Oregon, of the levy in the manner provided by law.


