

ORDINANCE NO. 1483

AN ORDINANCE levying a tax for the City of Albany, Oregon, upon the current assessment made on the taxable property for said City for the year 1939 for taxes to become due and payable in the year 1940 and to separately appropriate for each officer, department, building, institution, streets, highway, sewer, parks and other purposes, the amount of taxes so levied.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That it is hereby determined, declared and levied taxes in and for the City of Albany, Oregon, based upon the current assessment made on the taxable property therein for the year 1939, said taxes to become due and payable in the year 1940, in sums as follows, to-wit:
