

ORDINANCE NO. 1612

A Bill for an ordinance levying a tax for the City of Albany, Oregon, upon the current assessment made upon the taxable property within said city for the fiscal year from July 1, 1945, to July 1, 1946, for taxes to become due and payable upon such assessment for said period and to separately appropriate for each department of said city government and other public purposes thereof the amount of taxes so levied as provided by law.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That it is hereby determined, declared and levied, taxes in and for the City of Albany, Oregon, based upon the current assessment made upon the taxable property in said city for the fiscal year from July 1, 1945, to July 1, 1946, said taxes to for and to become due and payable within said period in sums as follows:

Said taxes are hereby levied upon the assessed valuation of all taxable property within said City of Albany, Oregon, as shown upon the current assessment roll in and for said City as the same appears in the office of the County Assessor in and for Linn County, Oregon.

Section 2. That from the fund derived from the levy hereby made and determined there is hereby appropriated for the fiscal year beginning July 1, 1945, and ending July 1, 1946, the sums set opposite the respective items as hereinabove set forth.

Section 3. The Recorder of the City of Albany is hereby directed to immediately notify the County Clerk and County Assessor of Linn County, Oregon, of the levy hereby made as provided by law.
