

ORDINANCE No. 1822

A BILL FOR:

AN ORDINANCE creating and establishing fire zones, and declaring an emergency.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

1. Fire Zone 1 shall be bounded by a line commencing at a point where the center line of Washington Street intersects the south bank of the Willamette River, and running thence southerly following the center line of said Washington Street to the center line of Third Street; thence easterly along the center line of Third Street to the center line of Ferry Street; thence southerly along the center line of Ferry Street to the center line of Fourth Street; thence easterly along the center line of Fourth Street to the center line of Ellsworth Street; thence northerly along the center line of Ellsworth Street to the center line of Third Street; thence easterly along the center line of Third Street to the center line of Baker Street; thence northerly along the center line of Baker Street to the south bank of the Willamette River; thence westerly along the south bank of the Willamette River to the place of beginning.

2. Fire Zone 2 shall be bounded by Fire Zone 1 and by a line commencing at a point where the center line of Washington Street intersects the south bank of the Willamette River and running thence southerly following the south bank of the Calapooia River to where it intersects the north boundary line of Third Street; thence easterly along the northern boundary line of Third Street to the center line of Calapooia Street; thence southerly following the center line of Calapooia Street to the center line of the alley between Fourth Street and Fifth Street; thence easterly along the center line of said alley to a point midway between Washington and Ferry Streets; thence southerly along the line midway between Washington and Ferry Streets to the center line of Fifth Street; thence easterly along the center line of Fifth Street to a point midway between Lyon and Baker Streets; thence northerly along the line midway between Baker and Lyon Streets to the center line of Fourth Street; thence easterly along the center line of Fourth Street to the center line of Montgomery Street; thence northerly along the center line of Montgomery Street to the south bank of the Willamette River; thence westerly along the south bank of the Willamette River to the place of beginning.

3. Fire zone 3 shall be bounded by Fire Zone 2 and the boundary line of the corporate limits of the City of Albany, Oregon.

All ordinances and parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

WHEREAS the peace, health and safety of the people of the City of Albany requires that this Ordinance shall become immediately effective; therefore, an emergency is hereby declared to exist and this Ordinance shall become in full force and effect immediately upon its final passage by the Council and approval by the Mayor.
