

ORDINANCE NO. 1054

A BILL FOR:

AN ORDINANCE to determine the probable cost of constructing lateral sewers which the Council of the City of Albany, Oregon has determined to make in Resolution No. 47 adopted by said Council on the 14th day of May, 1947 to construct lateral sewers in the City of Albany, Oregon, to-wit:

Beginning at the end of the existing lateral approximately 109 feet westerly of the existing manholes on the west side of West Street between Tenth and Eleventh Streets, and going thence southerly 149 feet, to Manhole Number 2 on the north line of Block 16, City View Addition; thence westerly 132 feet to proposed Manhole Number 3; thence southerly 70 feet. Also beginning at proposed Manhole Number 2 and going thence southerly 70 feet;

to ascertain, assess, determine and declare the proportionate share of such probable cost of such construction of said lateral sewers that is assessed upon each lot or part thereof to be so improved; to direct the Recorder of said City to enter a statement of such assessment in the Docket of City Liens as provided by the Charter of said City.

WHEREAS on the 14th day of May, 1947 the Council of the City of Albany, Oregon duly adopted a resolution requiring the City Engineer of said City to make plans and specifications for the construction of lateral sewers within the City of Albany as follows:

Beginning at the end of the existing lateral approximately 109 feet westerly of the existing manholes on the west side of West Street between Tenth and Eleventh Streets, and going thence southerly 149 feet, to Manhole Number 2 on the north line of Block 16, City View Addition; thence westerly 132 feet to proposed Manhole Number 3; thence southerly 70 feet. Also beginning at proposed Manhole Number 2 and going thence southerly 70 feet;

and for the estimates of the work to be done and the probable cost thereof and requiring that such plans, specifications, estimates and probable cost be filed in the Recorder's Office of said City, said Resolution being endorsed, "Resolution No. 46" and adopted the 14th day of May, 1947.

WHEREAS the City Engineer of said City of Albany pursuant to said Resolution No. 46 made plans, specifications and estimates as directed by the said Resolution for the construction of said lateral sewers in the manner specified in said Resolution No. 46 and filed said plans, specifications and estimates in the Recorder's Office of said City on the 14th day of May, 1947.

WHEREAS the Council on the 14th day of May, 1947, by Resolution No. 47 duly adopted by said Council, determined and resolved that it deemed it expedient and that said Council proposed to construct lateral sewers in the manner provided in said Resolution No. 47 in the City of Albany as follows:

Beginning at the end of the existing lateral, approximately 109 feet westerly of the existing manholes on the west side of West Street between Tenth and Eleventh Streets, and going thence southerly 149 feet, to Manhole Number 2 on the north line of Block 16, thence westerly 132 feet to proposed Manhole Number 3; thence southerly 70 feet. Also beginning at proposed Manhole Number 2 and going thence southerly 70 feet.

WHEREAS, in and by said Resolution No. 47 adopted as aforesaid by the Council the Recorder of said City was duly ordered and directed by said Council to give notice of said proposed construction of said lateral sewers as provided by the Charter of said City and:

WHEREAS the Recorder in pursuance of said order and direction of the Council of said City did duly give notice of said proposed construction of said lateral sewers in the manner provided by the Charter of said City and:

WHEREAS, the said Council in and by said Resolution No. 47 ascertained and determined the total probable cost of making said construction of said lateral sewers to be paid by the owners of the real property to be improved as specified in said Resolution No. 47 to be the sum of \$1374.61.

T H E R E F O R E

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

ORDINANCE NO. 1854 (Cont'd)

Section 1. That lateral sewers be constructed within the City of Albany as follows:

Beginning at the end of the existing lateral, approximately 109 feet westerly of the existing manholes on the west side of West Street between Tenth and Eleventh Streets, and going thence southerly 149 feet, to Manhole Number 2 on the north line of Block 16; thence westerly 132 feet to proposed Manhole Number 3; thence southerly 70 feet. Also beginning at proposed Manhole Number 2 and going thence southerly 70 feet;

all in accordance with said Resolution No. 47 and the plans and specifications for said construction of lateral sewers filed by the City Engineer with the Recorder of said City of Albany, Oregon on the 14th day of May, 1947.

Section 2. That the probable cost of making said construction of said lateral sewers in the manner heretofore determined by the Council of Albany in and by Resolution No. 47 to be paid by the owners of the real property to be so improved is hereby declared to be the sum of \$1374.61.

Section 3. That the proportionate share of said probable cost of said construction of said lateral sewers assessed upon each lot or part thereof to be improved as aforesaid and as determined by said Council in and by said Resolution No. 47 is hereby ascertained and declared to be the sum set and placed immediately after the separate descriptions of each of such lots or parts thereof as follows:

DESCRIPTION OF EACH LOT OR PART THEREOF TO BE IMPROVED
BY THE CONSTRUCTION OF SAID LATERAL SEWERS:

Ellingboe, S. K. and H. G. Beg. 79 ft. N. of Southeast corner of Lot 6, Bl. 16, City View Add., thence North 80 ft.; thence West 132 ft.; thence South 80 ft.; thence East 132 ft. to beginning \$261.87	
Casey, R. S. and J. A. Beginning at the Southeast corner of Lot 4, Bl. 16, City View Add.; thence North 149.33 ft.; thence West 66 ft.; thence south 145.51; thence easterly 66.3 ft. to beginning.	241.28
Burkhart, D. L. and D. M. Beginning at the Southwest corner of Lot 1, Bl. 16, City View Add.; thence North 65.09 ft.; thence East 118.10 ft.; thence south 73.70 ft.; thence westerly 127.22 ft. to beginning.	210.13
Holmes, G. Glenn Beginning at the Southeast corner of Lot 6, Bl. 16, City View Add.; thence north 79 ft.; thence West 132 ft.; thence south 69.33 ft.; thence easterly 132.6 ft. to beginning.	242.77
Holmes, G. Glenn Beginning at the Southwest corner of Lot 3, Bl. 16, City View Add.; thence North 139.70 ft.; thence East 66 ft.; thence South 145.51 ft.; thence West-erly 66.3 ft. to beginning.	233.40
Holmes, G. Glenn Beginning at a point 73.70 ft. North of the south-east corner of Lot 2, Bl. 16, City View Add.; thence West 118.10 ft.; thence North 66.62 ft.; thence East 108.17 ft.; thence South 66 ft. to beginning.	185.16

Section 4. That the Recorder of the City of Albany, Oregon is hereby ordered and directed to immediately enter a statement of the assessments made and declared by this ordinance together with the names of the respective owners of such lots or parts thereof hereinabove described in the Docket of City Liens of the said City of Albany, Oregon as provided in the Charter of said City.


