

A BILL FOR:

AN ORDINANCE DECLARING A SURPLUS AND A DEFICIT ON ACCOUNT OF THE IMPROVEMENT OF WEST AND NINTH STREETS, FROM THE NORTH LINE OF 12TH STREET TO THE SOUTH LINE OF NINTH STREET AND NINTH STREET FROM THE WEST LINE OF WEST STREET TO THE EAST LINE OF BROADWAY, IN THE CITY OF ALBANY, LINN COUNTY, OREGON, BY D. F. MCKENZIE, AND DIRECTING THE RECORDER OF SAID CITY TO PLACE TO THE CREDIT OR DEBIT OF THE SEVERAL OWNERS OF THE VARIOUS PARCELS OF REAL ESTATE ADJACENT TO SAID IMPROVEMENT HERETOFORE ASSESSED AND ENTERED OF RECORD IN THE DOCKET OF CITY LIENS OF THE CITY OF ALBANY, OREGON FOR THE MAKING OF SAID IMPROVEMENT, THEIR PROPORTIONATE SHARE OF SUCH SURPLUS OR DEFICIT.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a Surplus of \$603.75 and a deficit of \$316.59 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into, by and between the City of Albany, Oregon, and D. F. McKenzie for the improvement of WEST and NINTH streets, from the North line of 12th Street to the South line of 9th Street and 9th Street from the West line of West Street to the East line of Broadway, in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens of said City, in the surplus column and deficit column thereof, in the sum of \$603.75 and \$316.59 respectively, based upon the several amounts heretofore assessed for making such improvement, and entered therein to defray the cost of the improvement of said streets, said surplus and deficit in favor or against the various owners, or reputed owners, of the various parcels of real estate, and in the sums as follows, to-wit:
