

A BILL FOR:

AN ORDINANCE DECLARING A SURPLUS ON ACCOUNT OF THE IMPROVEMENT OF PINE STREET FROM THE NORTH LINE OF WATER STREET TO THE SOUTH LINE OF WILLAMETTE STREET AND FROM THE EAST LINE OF OAK STREET TO THE WEST LINE OF HARRISON STREET, IN THE CITY OF ALBANY, LINN COUNTY, OREGON, BY D. F. MCKENZIE, AND DIRECTING THE RECORDER OF SAID CITY TO PLACE TO THE CREDIT OF THE SEVERAL OWNERS OF THE VARIOUS PARCELS OF REAL ESTATE ADJACENT TO SAID IMPROVEMENT HERETOFORE ASSESSED AND ENTERED OF RECORD IN THE DOCKET OF CITY LIENS OF THE CITY OF ALBANY, OREGON FOR THE MAKING OF SAID IMPROVEMENT, THEIR PROPORTIONATE SHARE OF SUCH SURPLUS.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$1201.69 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into, by and between the City of Albany, Oregon, and D. F. McKenzie for the improvement of Pine Street from the North line of Water Street to the South line of Willamette Street and from the East line of Oak Street to the West line of Harrison Street, in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of the City Liens of said City, in the surplus column thereof in the sum of \$1201.69, based upon the several amounts heretofore assessed for making such improvement, and entered therein to defray the cost of the improvement of said street, said surplus in favor of the various owners, or reputed owners, of the various parcels of real estate, and in the sums as follows, to-wit:
