AN ORDINANCE DECLARING A SURPLUS AND A DEFICIT ON ACCOUNT OF THE IMPROVEMENT OF MONTGOMERY STREET, FROM THE SOUTH LINE OF THIRD STREET TO THE NORTH LINE OF THE MT. STATES POWER CANAL, IN THE CITY OF ALBANY, LINN COUNTY, OREGON, BY D. F. MCKENZIE, AND DIRECTING THE RECORDER OF SAID CITY TO PLACE TO THE CREDIT OR DEBIT OF THE SEVERAL OWNERS OF THE VARIOUS PARCELS OF REAL ESTATE ADJACENT TO SAID IMPROVEMENT HERETOFORE ASSESSUD AND ENTERED OF RECORD IN THE DOCKET OF CITY LIENS OF THE CITY OF ALBANY, OR DEFICIT.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$454.32 and a deficit of \$88.86 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into, by and between the City of Albany, Oregon and D. F. McKenzie for the improvement of Montgomery Street from the South line of Third Street to the North line of the Mt. States Power Canal, in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to mid improvement heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens of said City, in the surplus column and deficit column thereof, in the sum of \$4.54.32 and 388.86 respectively, based upon the several amounts heretofore assessed for making such improvement, and entered therein to defray the cost of the improvement, of said street, said surplus and deficit parcels of real estate, and in the sums as follows, to-wit:
