

ORDINANCE NO. 2418

AN ORDINANCE PROVIDING FOR THE DATE AND MANNER OF HOLDING A SPECIAL ELECTION IN A PORTION OF HAZELWOOD ADDITION ON THE 4th DAY OF NOVEMBER, 1952, FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF THE SAID TERRITORY FOR THEIR ADOPTION OR REJECTION A PROPOSAL TO ANNEX THE SAID PORTION OF HAZELWOOD ADDITION TO THE CITY OF ALBANY, OREGON, AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: That in a manner provided by law and in this ordinance and for the purpose set forth herein, a special election shall be held in a portion of Hazelwood Addition to the City of Albany, Linn County, Oregon, as below described, on the 4th day of November, 1952, commencing at the hour of 8:00 o'clock A. M. on the said day, Pacific Standard time.

Section 2: That the following is hereby designated as the voting place of the said election, the same being the regular voting place of the general election, held upon the same day as the special election:

Mason Residence, 820 Broadway, Albany, Oregon.

Section 3: That the judges and clerks of the said special election who shall supervise the election within the below described territory, shall be the same as those designated by the Linn County Court for the general election for the year 1952, for the Calapooia Precinct.

Section 4: The City Recorder shall cause notice of the said special election to be given by publication thereof in a newspaper of general circulation within the said city once a week for four (4) consecutive weeks, first date of publication to be the 10th day of October, 1952, and said notice shall state the time, voting place and a description of the territory proposed to be annexed.

Section 5: The Recorder, in addition to the notice required by Section 5, shall cause to be posted in four (4) conspicuous places within the territory proposed to be annexed at least ten (10) days before the date of the special election, notices of the special election in the following form:

"SPECIAL ELECTION NOTICE"

Notice is hereby given that on November 4, 1952, at the Mason residence, 820 Broadway, Albany, Oregon, in the Calapooia precinct in Hazelwood Addition to the City of Albany, Oregon, a special election will be held concerning the proposed annexation of the following described territory to the City of Albany:

Beginning at a point which is the southwest corner of Block 1, Albany Height's Addition, City of Albany, Linn County, Oregon; thence westerly to the southeast corner of Block 6, Hazelwood Addition, Linn County, Oregon; thence southwesterly along the northerly boundary line of the Oregon State Highway (Secondary Highway) to the place where the northern boundary line intersects the south line of Block 7, Hazelwood Addition, Linn County, Oregon; thence westerly along the south line of said Addition to the southwest corner of Block 28, Hazelwood Addition, Linn County Oregon; thence north along the west line of Block 28 to the northwest corner of Block 28, Hazelwood Addition; thence west along the south line of Seventeenth Avenue, Hazelwood Addition, to a point which intersects the west line of Block 31, Hazelwood Addition, if extended southerly; thence northerly to the northwest corner of Block 31, Hazelwood Addition; thence easterly to the northeast corner of Block 31, Hazelwood Addition; thence northerly along the west boundary line of Marion Street, Hazelwood Addition, to a point which is the intersection of the south line of Fifteenth Avenue and the west line of Marion Street, Hazelwood Addition; thence easterly along the north line of Blocks 30 and 25 to the northwest corner of Block 23, Hazelwood Addition; thence northerly along the west line of Block 24 to the northwest corner of Block 24, Hazelwood Addition; thence easterly along the north line of Block 24, Hazelwood Addition, to the northwest corner of Block 17 of said addition; thence northerly along the east boundary line of Hop Street to a point which is the intersection of the east line of Hop Street and the south boundary line of Sprenger's Supplemental Plat to Hazelwood Addition, Linn County, Oregon; thence easterly along the south line of Block 1, Sprenger's Supplemental Plat to Hazelwood Addition, Linn County, Oregon, to the west line of Lincoln Street in Hazelwood Addition, Linn County, Oregon; thence northerly along the east line of Block 1, Sprenger's Supplemental Plat to Hazelwood Addition, Linn County, Oregon, to the north boundary line of Tenth Street in Hazelwood Addition; thence continuing on the same course to a point on the north claim line of D.L.C. No. 84, Township 11 S., Range 4 W. Willamette Meridian; Linn County, Oregon; thence easterly along the north line of said D.L.C. to the northeast corner of said claim and extending on this same course to a point which is the intersection of the north line of this claim and the east line of Broadway Street, Albany, Oregon; thence southerly along the east line of Broadway Street to the point of beginning.-----

which election will be held at 8:00 o'clock in the morning and will continue until 8:00 o'clock in the afternoon Pacific Standard Time of the said day.

Registered voters in the said territory are invited to vote upon the proposed annexation.

Section 6: At the said special election, the proposed annexation of the territory described below shall be submitted to the legal voters of the said territory for their adoption or rejection as hereinafter set forth in Section 7.

Section 7: The ballot title of the proposed annexation submitted to the registered voters of the said territory shall be as follows:

PROPOSAL TO ANNEX A PORTION OF HAZELWOOD ADDITION TO THE CITY OF ALBANY, LINN COUNTY, OREGON.

AN ACT to annex the following described territory, (being a portion of Hazelwood Addition to the City of Albany, Linn County, Oregon), to the City of Albany:

Beginning at a point which is the southwest corner of Block 1, Albany Height's Addition, City of Albany, Linn County, Oregon; thence westerly to the southeast corner of Block 6, Hazelwood Addition, Linn County, Oregon; thence southwesterly along the northerly boundary line of the Oregon State Highway (Secondary Highway) to the place where the northern boundary line intersects the south line of Block 7 Hazelwood Addition, Linn County, Oregon; thence westerly along the south line of said Addition to the southwest corner of Block 28, Hazelwood Addition, Linn County, Oregon; thence north along the west line of Block 28 to the northwest corner of Block 28, Hazelwood Addition; thence west along the south line of Seventeenth Avenue, Hazelwood Addition, to a point which intersects the west line of Block 31, Hazelwood Addition, if extended southerly; thence northerly to the northwest corner of Block 31, Hazelwood Addition; thence easterly to the northeast corner of Block 31, Hazelwood Addition; thence northerly along the west boundary line of Marion Street, Hazelwood Addition, to a point which is the intersection of the south line of Fifteenth Avenue and the west line of Marion Street, Hazelwood Addition; thence easterly along the north line of Blocks 30 and 25 to the northwest corner of Block 23, Hazelwood Addition; thence northerly along the west line of Block 24 to the northwest corner of Block 24, Hazelwood Addition; thence easterly along the north line of Block 24, Hazelwood Addition, to the northwest corner of Block 17 of said Addition; thence northerly along the east boundary line of Hop Street to a point which is the intersection of the east line of Hop Street and the south boundary line of Sprenger's Supplemental Plat to Hazelwood Addition, Linn County, Oregon; thence easterly along the south line of Block 1, Sprenger's Supplemental Plat to Hazelwood Addition, Linn County, Oregon, to the west line of Lincoln Street in Hazelwood Addition, Linn County, Oregon; thence northerly along the east line of Block 1, Sprenger's Supplemental Plat to Hazelwood Addition, Linn County, Oregon, to the north boundary line of Tenth Street in Hazelwood Addition; thence continuing on the same course to a point on the north claim line of D.L.C. No. 84, Township 11 S, Range 4W of the Willamette Meridian, Linn County, Oregon; thence easterly along the north line of said D.L.C. to the northeast corner of said claim and extending on this same course to the point which is the intersection of the north line of this claim and the east line of Broadway Street, Albany, Oregon; thence southerly along the east line of Broadway Street to the point of Beginning.---
