ORDINANCE NO. 2626

AN ORDINANCE ASSESSING CERTAIN PROPERTY FOR THE CUTTING AND REMOVAL OF GRASS THEREFROM; DIRECTING THE RECORDER TO ENTER SUCH ASSESSMENTS IN THE LIEN DOCKETS OF THE CITY.

Recitals:

1. Ordinance No. 1321 provides that the Chief of the Fire Department shall abate, as a nuisance, grass from property as described in the said ordinance, report the costs thereof to the Council, and authorizes the Council to adopt the report and assess the costs thereof to the property.
2. The Chief of the Fire Department filed a report with the Recorder on December 12, 1955, setting forth the property and costs in abating the nuisances.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: The report of the Chief of the Fire Department as to costs and property upon which he has abated nuisances, filed with the Recorder December 12, 1955, is hereby adopted.
