

ORDINANCE NO. 2821

AN ORDINANCE AMENDING ORDINANCE NUMBERS 2702, 2755, 2756 AND 2760 FOR THE PURPOSE OF SEGREGATING CERTAIN LIENS IN THE CITY OF ALBANY, OREGON.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: That Ordinance Numbers 2702 and 2760 be amended to segregate Lots 1 and 2, Block 5 Hazelwood Addition to the City of Albany, Linn County, Oregon, herein created on the property in the following manner:
