

ORDINANCE NO. 2885

**TITLE:** AN ORDINANCE ELECTING TO DISPENSE WITH AN ELECTION WITHIN THE CITY OF ALBANY PURSUANT TO 222.120 ORS REGARDING ANNEXATION OF AREA 2 - BOWMAN & DALY ADDITION, A PORTION OF 1ST ADD. TO VISTA HOMES AND ADJACENT AREAS; SETTING A TIME FOR PUBLIC HEARING ON THE SAME AND DECLARING AN EMERGENCY.

**RECITALS:**

Whereas, it has heretofore been determined to hold an election in an area herein described for the purpose of determining whether or not the residents in the area desire to be annexed to the City of Albany,

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: DESCRIPTION OF PROPERTY

That an election within the City of Albany for the purpose of annexing the following described property, to-wit:

Beginning at a point on the present city boundary line that is at the intersection of the S. margin of Queen Ave. and the W. line of Oak St.; thence Westerly along the city limits line; thence Southerly; thence Easterly; thence Southerly; thence Easterly, all along present city limits line, to the N.W. corner of Lot 1, 1st Add. to Rodgers Acres; thence Easterly along the N. line of 1st Add. to Rodgers Acres to the W. margin of Geary St.; thence Southerly along the W. margin of Geary St. to the present city limits line, which is the S. margin of 34th Ave.; thence along present city limits line Easterly; thence Northerly; thence Westerly; thence Northerly to the S. margin of Grand Prairie Rd.; thence Westerly along the S. margin of Grand Prairie Rd. to the W. margin of Geary St.; thence Northerly along the margin of Geary St. to the N. margin of Queen Ave. extended Easterly; thence Westerly along the N. margin of Queen Ave. extended Easterly to the W. margin of Oak St.; thence Southerly to the S. margin of Queen Ave., which is the point of beginning,

shall be and is hereby dispensed with pursuant to and under the terms of 222.120 ORS.

Section 2: TIME AND PLACE OF HEARING - NOTICES

That there shall be held a public hearing as to the advisability of annexing Area 2, Bowman & Daly Addition, a portion of 1st Add. to Vista Homes and adjacent areas, described in Section 1, to the City of Albany on the 23rd day of December, 1959, at the hour of 7:15 o'clock p.m. in the City Hall, Albany, Oregon, and the City Recorder of the City of Albany is hereby directed to give notice of the said public hearing by publishing in a newspaper of general circulation in said city once a week for two (2) successive weeks prior to the election and by posting a notice in four (4) public places for the same length of time setting forth the time and place of said hearing and the description of property to be considered for annexation and the purpose for which the hearing is held.

Section 3: EMERGENCY CLAUSE

Whereas, it is for the betterment of the public health, interest, safety and general welfare of the citizens of the City of Albany that this



matter of annexation of property described herein be disposed of at the earliest possible moment and an emergency is hereby declared to exist and this ordinance shall become immediately effective upon its passage by the Council and approval by the Mayor.
