

AN ORDINANCE ELECTING TO DISPENSE WITH AN ELECTION WITHIN THE CITY OF ALBANY, OREGON, UNDER THE PROVISIONS OF ORS SECTION 222.111, 222.120 AND 222.170, REGARDING THE ANNEXATION OF AN AREA LOCATED AT THE SOUTHWEST CORNER OF BAIN AND LANSING STREETS, CONTIGUOUS TO THE CITY OF ALBANY, SETTING A TIME FOR PUBLIC HEARING ON THE SAME AND DECLARING AN EMERGENCY.

WHEREAS, 100 per cent of the owners of the property which is the subject matter of this annexation have petitioned and requested the City of Albany to annex the area hereinafter described to the City of Albany, and the same being contiguous and in all respects qualifying under present statutes for annexation, and

WHEREAS, it is in the best interest of the City of Albany that a public hearing be held at the earliest possible date to consider objections to the annexation of the property herein described.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: DESCRIPTION OF PROPERTY

That an election within the City of Albany regarding the annexation of the following described property to-wit:

- a) The Ely  $\frac{1}{2}$  of Lt. 6, Bl 2, Glendorr, more part. desc as follows, to-wit: Beg at a  $\frac{3}{4}$ " pipe at the NE cor of Lt 6, Bl 2, Glendorr; th Wly alg the N li of sd Lt 6, 100' to a 1" pipe; th S  $19^{\circ}47'$  W 200', to the S li of sd Lt 6; th Ely alg S li of sd Lt 6, 100' to the SE cor of Lt 6; th N  $19^{\circ}47'$  E alg the E li of sd Lt 6, 200' to pob
- b) That pt of Lt 8, Bl 1, Glendorr desc. as follows, to-wit: Beg at a pt on the Wly li of Queen Anne Street at the SE cor of sd Lot 8, th Nly alg the E li of sd Lt 8, to the S bound. of Locust Ave in Freeway Add to Albany; th Wly alg the S bound. of sd Locust Ave to its intersection wi the W li of sd Lt 8; th Sly alg the W li of sd Lt 8 to the SW cor of Lt 8; th Ely alg the S li of sd Lt 8 to the place of beg.
- c) All of Lt 6 and the following desc portion of Lts 2 and 4 in Bl 1, Glendorr, to-wit: Beg at the most Wly cor of sd Lot 4, th N  $19^{\circ}47'$  E 200.15' to the most Northerly cor of sd Lt 4; th S  $70^{\circ}17'$  E 100' alg the Nly bound. of sd Lt to a pt midway betw. the most Nly and mo Ely cor of sd Lt 4; th S  $19^{\circ}47'$  W 230.15' parallel to the Wly bound. of sd Lts 2 & 4 to a  $\frac{5}{8}$ " rod 30' S  $19^{\circ}47'$  W from the Nly boundary of sd Lt 2; th N  $70^{\circ}17'$  W 100' to a  $\frac{5}{6}$ " rod on the Wly bound of sd Lt 2; th N  $19^{\circ}47'$  E 30.15' to pob
- d) Pt of Bl 2, Glendorr, desc as follows: beg at a  $\frac{1}{2}$ " ir pipe at the most Nly cor of Lt 7, Bl 2, Glendorr; th S  $70^{\circ}36'$  E 400' to the mo Ely cor of Bl 2, Glendorr, to a  $\frac{1}{2}$ " ir pipe; th S  $19^{\circ}47'$  W 200' to a  $\frac{3}{4}$ " pipe, at the SE cor of Lt 8; th NWly alg the S li of Lt 8, 100' to a 1" pipe; th S  $19^{\circ}47'$  W 200' to the S li of Lt 6; th NWly alg the Sly li of Lts 6 & 5, 200'; th  $19^{\circ}47'$  E 25', to a  $\frac{1}{2}$ " rod; th NWly, parallel with the Sly li of Lt 5, 100' to a  $\frac{1}{2}$ " rod on the E li of Anne St which is also the W boundary of Lt 5, th NEly along the W bound. of Lts 5 & 7 to the pob

be dispensed with.

Section 2: HEARING

THAT there shall be a public hearing as to the advisability of annexing the property described in Section 1 to the City of Albany, on the 9th day of July 1969, at 7:15 p.m. o'clock, and the City Recorder is hereby directed to give notice of said public hearing by publishing in a newspaper of general circulation, published in the said City once a week for two (2) successive and consecutive weeks and by posting in four (4) public places, a notice setting for the time and place of said hearing and the description of the property to be considered for annexation and the purpose for which the hearing is held.

Section 3: EMERGENCY CLAUSE

WHEREAS, it is in the betterment of the public health, interest, safety and general welfare of the citizens of the City of Albany that this matter of annexation of the property

described herein be disposed of at the earliest possible moment, and, should be the same annexed, that the City facilities be made available to this property, therefore, an emergency is hereby declared to exist and this ordinance shall become immediately effective upon its passage by the Council and approval by the Mayor.
