

ORDINANCE NO. 1488

AN ORDINANCE ELECTING TO DISPENSE WITH AN ELECTION WITHIN THE CITY OF ALBANY, OREGON, UNDER THE PROVISIONS OF ORS SECTION 222.111, 222.120 AND 222.170, REGARDING THE ANNEXATION OF AN AREA LOCATED AT THE NORTHWEST CORNER OF BAIN STREET AND SANTIAM HIGHWAY, CONTIGUOUS TO THE CITY OF ALBANY, SETTING A TIME FOR PUBLIC HEARING ON THE SAME AND DECLARING AN EMERGENCY.

WHEREAS, 100 per cent of the owners of the property which is the subject matter of this annexation have petitioned and requested the City of Albany to annex the area hereinafter described to the City, and the same being contiguous and in all respects qualifying under present statutes for annexation, and

WHEREAS, it is in the best interest of the City of Albany that a public hearing be held at the earliest possible date to consider objections to the annexation of the property herein described.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: DESCRIPTION OF PROPERTY

That an election within the City of Albany regarding the annexation of the following described property to-wit:

- a) W 100' Lot 4 and S 50' Lot 3 and All Lot 1, Blk 2, Glendorr Tr. EXC pt in hwy (11 3W 8AA 1500)
- b) N 150' of E 1/2 Lot 3, Blk 2, Glendorr (11 3W 8AA 1501)
- c) W 130' Lot 2, Blk 2, Glendorr EXC pt in hwy (11 3W 8AA 1502)
- d) N 66 2/3' of E 100' Lot 4, Blk 2, Glendorr Tr (11 3W 8AA 1900)
- e) S 66 2/3' of N 133 1/3' of E 1/2 Lot 4, Blk 2, Glendorr Tr. (11 3W 8AA 2000)
- f) Beg at NE cor Lot 2, Blk 2, Glendorr; th Wly 70'; th Sly 75'; th Ely 70'; th Nly 75' to begin (11 3W 8AA 2200)

As R-6 Residential Zone

ALSO:

- g) Beg N 1°39' W 6192.6' and S 70°39' E 767.1' fr Sw Cor DIC 49; th N 19°21' E 125'; th N 70°39' W 70'; th S 19°21' W 125'; th S 70°39' E 70' to begin EXC pt in hwy (11 3W 8AA 2300)

As C-2 Local Commercial Zone

be dispensed with.

Section 2: HEARING

That there shall be a public hearing as to the advisability of annexing the property described in Section 1 to the City of Albany, on the 24th day of June, 1970, at 7:15 p.m. o'clock, and the City Recorder is hereby directed to give notice of said public hearing by publishing in a newspaper of general circulation, published in the said City once a week for two (2) successive and consecutive weeks and by posting in four (4) public places, a notice setting forth the time and place of said hearing and the description of the property to be considered for annexation and the purpose for which the hearing is held.

Section 3: EMERGENCY CLAUSE

WHEREAS, it is in the betterment of the public health, interest, safety and general welfare of the citizens of the City of Albany that this matter of annexation of the property described herein be disposed of at the earliest possible moment, and should the same be annexed, that the City facilities be made available to this property, therefore, an emergency is hereby declared to exist and this Ordinance shall become immediately effective upon its passage by the Council and approval by the Mayor.
